Our Federal Delegation Visits the Capitol

Over the past month, Congresswoman Mary Peltola and U.S. Senators Dan Sullivan and Lisa Murkowski visited legislators in the Capitol and addressed both the House and Senate in joint sessions. This was Congresswoman Peltola's first address to the Legislature since being elected in 2022 and marked the first time in decades Alaska's sole member of Congress addressed the Legislature.

State of the Judiciary Address

Chief Justice Daniel Winfree offered his final State of the Judiciary Address to the Alaska Legislature before his retirement. In his address, the Chief Justice offered an update on the status of the judiciary, which has returned to nearly the same level of productivity as before the pandemic and is working its way through the backlog of cases that arose over the past two years. The Chief Justice also addressed the challenges presented by challenges with the recruitment and retention of public defenders, particularly in rural communities. Of note, the Chief Justice strongly defended and advocated for Alaska's apolitical selection process for judges which some politicians have aimed to change to a more politically-charged appointment process. He also commended the hard work and dedication of our judicial branch and workers.

Budget Subcommittees

The Alaska State House has been working through the FY 2024 State Operating Budget in the budget subcommittee process. These subcommittees consist of members of the House Finance Committee and members of both the House majority and minority. Each subcommittee is tasked with auditing the budget and operations of each respective state department, such as the Departments of Education and Early Development (DEED), Labor and Workforce Development, Public Safety, Revenue, etc. I'm grateful to serve on the Finance Subcommittees for the Department of Environmental Conservation as well as the budgets for the Governor's office and Legislature.

Once the budget subcommittee process closes out, the House Finance Committee will then begin working on the full FY 2024 operating budget. In the Senate, the Finance Committee members are working with other legislators across the state on capital projects as they work through the FY 2024 Capital Budget.

Alaska House Coalition's Press Availability

I joined members of our House Coalition, including Representatives Dan Ortiz, Rebecca Himschoot, and Maxine Dibert, who are experienced educators, to outline our legislative priorities for the year with a focus on educational improvements to help provide all Alaskan students a high-quality education. Our top priority is increasing the Base Student Allocation to ensure schools and classrooms have the resources they need and work to address challenges recruiting and retaining skilled and experienced education professionals. Base Student Allocation Funding Increase

One of the top priorities advocated for by both the House and Senate Coalitions is the need to provide additional funding for Alaska's students, teachers, and schools through an increase to the Base Student Allocation (BSA). In both chambers, legislation has been introduced to provide increased funding, including House Bill 65 by Rep. Ortiz and Senate Bill 52 by the Senate Education Committee. Both bills aim to meet the needs of Alaska's education system which has faced years of flat funding in the wake of growing inflation rates, serving as an effective cut to schools across our state. With growing pressure for Alaskans, I am optimistic we will be able to provide a meaningful increase to education funding and I will do all I can to help accomplish it.

IRS Releases Guidance the \$662 Alaska Energy Relief Payment in 2022 will not be considered taxable income

The IRS has informed the state that the \$662 energy relief payment Alaskans received last year with their dividend will not be taxable. Formal guidance on how to prepare 2022 tax returns for this payment will be provided in the near future which I will work to share once it's released.

Clean Energy Tax Credits for Consumers

The U.S. Department of Energy is offering tax credits to consumers, renters, and homeowners for energy efficient home improvement and residential clean energy property improvement upgrades, appliances, and products. Some of the investments covered include solar panels, home back-up power storage, electric or natural gas heat and water pumps, central air conditioners, natural gas, propane, or oil water heaters, gas or oil furnaces and water boilers, insulation materials, efficiency windows, and more. https://www.energy.gov/policy/articles/making-our-homes-more-efficient-clean-energy-tax-credits-consumers
