The purpose of the Bicycle Plan is to increase bicycle facilities and the use of bicycles for transportation. A public draft version of the plan was circulated for comments in March 2009. Over 200 comments were received. A [Public Hearing Draft](#), August 2009 was heard at the Planning and Zoning Commission and approved in November. The Commission conducted a public hearing to obtain additional comments, and provide recommendations. A resolution approving the Draft Plan, and noting recommended changes to the Plan is [here](#). The Anchorage Assembly will conduct a public hearing in January or February 2010 as part of the process to adopt the plan. Dates for the Assembly public hearing will be posted on this page. AMATS will make the final approval.
