Birchwood Community Council Resolution 22-01-01

Whereas the Municipality of Anchorage's proposed AO 2022-14 refers to the "Eagle River and Chugiak area," and AO 2022-18 refers to voters in the "Birchwood, Chugiak, Eagle River, Eklutna, and Peters Creek area", referring in both cases to the same area;

Whereas the area referenced includes the community council areas of Eagle River, Eagle River Valley, South Fork, Birchwood, Chugiak, and Eklutna Valley, referred to in the rest of this resolution as "Eagle River/Chugiak" or "the area";

Whereas the Anchorage Assembly is considering holding an advisory vote by all voters in the Municipality on whether Eagle River/Chugiak should detach from the Anchorage Municipality and form a separate local government (AO 2022-14*);

Whereas the Anchorage Assembly is also considering an advisory vote by voters in Eagle River/Chugiak on whether the area should study its potential to detach from the Municipality of Anchorage and establish a separate local government unit (AO 2022-18**);

Whereas none of the six community councils in the Eagle River area have requested either a vote or a study;

Whereas funds of the Eagle River/Chugiak Parks and Recreation service area may only be spent on parks and recreation uses, and not broader questions of governance and taxation; and

Whereas the funds of the Chugiak Birchwood Eagle River Rural Road Service Area may only be spent on road maintenance in the service area, and not on broader questions of governance and taxation; and

Whereas, considering the previous two points, the voters advising on a study have no tax capacity to fund such a study separate from the broader Anchorage Municipality general fund;

Whereas a vote, even advisory, on detachment should be taken when voters have access to reliable information on the effects of such action; and

Whereas the voters have had little reliable and unbiased analysis to assess the impact of such detachment on taxation, education and local government operations, and

Whereas voters at this time have not expressed through their community councils, a desire for such information:

Therefore, the Birchwood Community Council opposes both ordinances, and requests that the Anchorage Assembly drop both Ordinances and not proceed with either at this time.
