REQUEST FOR RELEASE OF FUNDS

On or about May 23, 2011 10:00 AM the Municipality Of Anchorage will submit a request to the U.S. Department of Housing and Urban Development (HUD) for the release of Economic Development Initiative (EDI) program funds under 24 CFR 58.43 and 24 CFR 58.70, to undertake a project known as Anchorage Community Land Trust (ACLT) property acquisition. ACLT plans to acquire two adjoining lots, which are located at 3701 and 3709 Mountain View Drive, Anchorage, Alaska 99508. ACLT wants to ensure that future commercial use of the property is consistent with neighborhood needs and desires to stimulate commercial revitalization and promote private investment along the Mountain View Drive corridor.

Future use of this property will be consistent with its current B-3 zoning "Multiple Family - General Business" District. "The B-3 business district is intended for general commercial uses in areas exposed to heavy automobile traffic...where personal and administrative services, convenience and

shopping goods, and automobile-related services are desirable and appropriate land uses." ACLT will not use this property for:

- Residential uses
- Rooming houses
- Adult care facilities
- Hospital, nursing facilities
- · Transitional living facilities
- Residential care facilities
- B-3 uses subject to conditional use requirements

ACLT plans to use \$389,600 EDI-SP Grant #B-10-SP-AK-0011 funding for the following activities:

- Property acquisition: \$360,000
- Decommission UST: \$8,500
- Soil removal, if required, at 150% of estimated cost: \$15,000
- Lead Based Paint (LBP) and Asbestos inspection: \$1,500
- Other project related professional services: \$4,600

The structure located at 3701 Mountain View Drive was constructed in 1970 and the structure located at 3709 Mountain View Drive was constructed in 1960. The structures are separated by a common wall and connected by an unfinished doorway. The structures are connected to natural gas, Municipal water, and municipal sewer.

There appears to be an under ground storage tank located on the property that will be removed as part of the project. The soil will be tested and contaminated soil will also be removed. The structures will also be test for LBP and Asbestos as part of the project.

FINDING OF NO SIGNIFICANT IMPACT
