Anyone 18 years old and who resides in Chugiak or who owns property in Chugiak is eligible to run for election to these positions. If there is no community volunteer for a particular district, then any eligible person may volunteer to fill the vacant seat "at large". Terms run for two years. Minimum duties include attending our monthly meetings.

Once the Board has been seated, we will elect officers: President; Vice President; Secretary; and Treasurer. These positions have additional duties described in the Council's bylaws.

We will also be electing a primary delegate and an alternate delegate to the Federation of Community Councils.
