RE: The Public Review Draft MOAHPP comment period ends April 30, 2018.

Dear Community Council Members,

Hard copies of the *MOAHPP* were distributed to all community councils the week of March 5, 2018. We have received positive comments from many of you in phone calls or conversations.

We have been asked, "what are the specific sections of the plan that the Community Councils should focus on?" May I suggest the following sections to help streamline your review and responses; **Sections 6, 7, 8 and 9**, and the **Introduction**.

- **Section 6** Discusses the "Benefits" of Historic Preservation (*Have we included the benefits the community council thinks historic preservation can bring to their area*).
- Section 7 Outlines a new process the MOA would adopt, after the MOAHPP is approved by the Assembly, to identify locally important landmarks and landmark districts, a registration process for adopting the landmarks, and ways to protect the local landmarks (Does the community council agree that a local landmark process is a good idea, does the idea support and align with any other Plans adopted for your area). Landmarks are defined in Section 7 as several different things and not just buildings.
- **Section 8** Describes the visions, goals, and policies developed from the two Guiding Themes: "Social Benefits" of Historic Preservation and "Economic Benefits" of Historic Preservation (*Do the goals reflect what's important to the community council area, and align with any adopted Plans for this area).*
- **Section 9** Includes the Action Items (*Do we need to add more action items, is there something specific the community council wants in there*). Action items can also be included from past Capital Improvement programs, or park and trail planning efforts.
- **Introduction** Purpose of the Plan (*Does the Purpose of this plan meet what the community council thinks a historic preservation plan should do*).


