West High Parking Lot Improvements

A project completed this summer at the West High parking lot includes a dedicated school bus drive land; and medians, landscaping, and marked crosswalks, greatly enhancing and improving vehicle/pedestrian safety and bus circulation. • Turnagain Heights (Marston Dr/Foraker Dr.) RID/LID/WID Assessment Appeal

On August 10th, Superior Court Judge Eric A. Aarseth issued an "Order AFFIRMING Anchorage Municipal Assembly's Assessment Decision" regarding assessment costs for the Turnagain neighborhood road, water and sewer/lateral improvement districts. (Background: In 2003, cost assessments for the improvements were estimated and the Assembly authorized three improvement districts. In 2006, 35% designs showed the project would be more expensive; landowners unhappy with the Assembly's 2006 reassessed allocations filed an appeal. In 2013, the Court remanded the case to the Assembly, to hold a trial-type hearing for the Appellants' challenges to the new assessment rolls; a three-member Assembly panel held a quasi-judicial hearing in 2014. The Assembly concluded that costs were properly allocated, bidding procedures properly followed, and the lot owners received substantial benefit from the road, water, and sewer improvements. The Appellants then appealed the Assembly's remand decision to the Alaska Superior Court.)

Sydney's Shortcut Trail

The Office of the Municipal Attorney released a letter July 14, 2016, on the legal status of Sydney's Shortcut — a neighborhood path that cut across what was once a vacant lot on Marston Dr. connecting with the Coastal Trail — but closed off when development on the property started in 2015. The letter stated that, "Because the deed specifically grants a right of way to 'the owners of property in the Turnagain Heights Subdivision,' and not the Municipality or the public at large, the Municipality has not sought to enforce rights created by the 1955 deed." While this issue was discussed numerous times at TCC meetings, the council did not take a position on the matter.

Anchorage Bowl Land Use Plan Map Update

The Municipal Planning Dept. has posted more maps and information on the project website (see below), including Map Folio (Appendix A, draft) with 20 maps showing city planning factors and issues; "Traded Sectors" report (Appendix B) identifying land uses that are key export sectors of the local economy; the "Anchorage Industrial Land Assessment Update, Volumes 1 and 2, which assesses the remaining supply of industrial land in the Municipality; and Public Comments (Appendix D) received regarding the February 29 Community Discussion Draft Land Use Plan Map. Fish Creek Trail Improvements Project Design Study

This mile-long project includes upgrades to a southern section of Fish Creek Trail between 45th Ave. and the Taft St./W. Tudor Rd. intersection and a northern section between Kiwanis Fish Creek Park and Barbara Street Park. Trail upgrades include resurfacing trail, replacement of four Fish Creek bridges, replacement of lighting, minor improvements to the trail grade and alignment, and removal of select nearby trees and installation of root barriers to reduce future pavement damage caused by root intrusion. Design will continue through 2016, and construction is anticipated to begin summer 2017. The 2016 Alaska Transportation Alternatives Program (ATAP) recently awarded the "Fish Creek Trail Extension" project \$860,000.
