## **Public Notice**

ADL 56109: Public Utilities easement and Public Access easement, Asplund Wastewater Treatment Facility Effluent Tower, Point Woronzof. Applicant: Anchorage Water & Wastewater Utility, Engineering Division


Pursuant to Alaska Statue 38.05.850, the Department of Natural Resources (DNR), Division of Mining, Land, and Water (DMLW), Southcentral Regional Office is considering a request from Anchorage Water & Wastewater Utility Engineering Division to amend an existing Public Utility Easement for the Asplund Wastewater Treatment Facility Effluent Tower and pipeline to include an erosion control structure. The purpose of this erosion control structure is to protect the existing Effluent Tower. The proposed easement is to be located on State-owned, DMLW-managed tidelands within:

• Section 20 of Township 13 North, Range 4 West, Seward Meridian.

The dimensions of the proposed easement are approximately 120 feet in length, from mean high water to sea, 300 feet in width and would occupy approximately 0.83 acres of State land. The construction of the erosion control structure is proposed to consist of the placement of bedding and armor stone atop a geotextile material. As part of this project a six feet wide pedestrian walk way will be constructed to allow the public to cross the erosion control structure. The attached depiction shows the proposed easement is indicated in Attachment A. As part of the adjudication of this easement, DNR is considering the authorization of a public access easement, approximately 50 feet in width on state owned tide lands, around Point Woronzof within Sections 20 and 21 of Township 13 North, Range 4 West, Seward Meridian to facilitate future public access.

Members of the public and interested parties are invited to comment on this project. <u>DMLW</u> <u>must receive written comments no later than 5:00 pm January 12, 2017</u>. In order to be given full consideration, all comments should clearly explain the facts on which they are based and how they pertain to the proposed easement.
