A RESOLUTION OF THE RABBIT CREEK COMMUNITY COUNCIL IN REGARDS TO THE GOLDEN VIEW DRIVE INTERSECTION AND SAFETY UPGRADES – RABBIT CREEK ROAD TO ROMANIA DRIVE PROJECT

WHEREAS the State of Alaska appropriated legislative grant monies totaling approximately \$7.5M to be administered by the Municipality of Anchorage for the project entitled Golden View Drive Intersection and Safety Upgrades - Rabbit Creek Road to Romania Drive, and

WHEREAS this project is a high priority for the Rabbit Creek Community Council (RCCC), the South Goldenvue Rural Road Service Area, the Anchorage School District, the Traffic Department, and the surrounding neighborhoods, and **WHEREAS** the Municipality of Anchorage's Project Management & Engineering Department prepared design studies and 65% plans, specifications and estimates for the project, and

WHEREAS due to the current and projected unavailability of funds to construct the project, the Municipality of Anchorage has opted to postpone the project indefinitely, and

WHEREAS the RCCC Officers and Board Members endorse obligating a portion of the remaining grant monies for design, right-of-way acquisition and construction of safety improvements at the Golden View Drive / Bluebell Drive intersection, and

BE IT THEREFORE RESOLVED THAT the RCCC agrees to endorse the obligation of these funds to the Golden View Drive/Bluebell Drive Intersection Safety project.
