To view information about crime activity in Bear Valley (or other areas of Anchorage), go online to [accpatrols.org](http://accpatrols.org). Click on the LexisNexis Community Crime Map. Under Jump to City, select AK - Anchorage from the drop down arrow menu. Type in a specific street address followed by, Anchorage to specify a location. (For example, type: 15001 Mountain Air Drive, Anchorage.) You can change the Buffer by clicking it to On and using the drop down arrow to pick 1 mile, 2 miles, etc. You can also change Event to Select All, or pick a specific category of crime. Change the Date Range as desired. View by clicking the Map or Satellite tab, or list Incidents by clicking the Data Grid tab.
