DRAFT Turnagain Community Council Minutes
Meeting Summary October 2006

I. APD Liaison. Sgt. Cindi Stanton discussed crime issues in our area.

II. Announcements. Mark Wiggin invited ideas on a new Turnagain Subdivision sign. Bill Madsen of the Spenard Hostel Internation lost his case before Planning & Zoning. TCC supported his effort but it is not known what he plans on doing at this point. TCC elections will be held in November. Cathy Gleason handed out Community Council Volunteer Awards. The September minutes were approved.

III. Turnagain School Ice Rink. In response to a presentation by Laura Zetler, Turnagain Elementary PTA Ice Rink Coordinator, the TCC voted to donate \$750 towards maintenance of the ice rink which is open to community members.

IV. Pump Station 10 Project. Mark Wiggin lead a discussion of AWWU's truck routing and traffic plan proposals as well as discussions at the TCC subcommittee meetings with AWWU on the Pump Station 10 construction traffic issues.

V. Legislative Report. Sen Hollis French gave the legislative report discussing his interest introducing a health insurance bill.

VI. House District 26 Candidate's Forum. The TCC heard from Lindsey Holmes and Steve Strait who are running for the State House District 26 seat being vacated by Ethan Berkowitz.
