An attendee from Church was present at Jan meeting but not at subsequent meetings. The Community ouncil had contacted contractor both verbally and in writing, and contractor stated no meeting could be held without approval of ANH who is primary sponsor of the project on Jamestown which resulted in permitting contractor to use Cornerstone Church area as an access for equipment.

In March contact with ACS and GCI resulted in lines still draped over fences.

In May 2008, ACS inspected lines and said GCI would still have to be involved in reburying these utility lines. It may be done by July 2008.

On weekend of May 16 2008 Cornerstone Church, without prior notification to Thuja Residentts or Independence Park residents began tarring the roof, using their adjacent parking lot for equipment. The visible air pollution as well as the pervasion odor was HORRIBLE. Thuja Ave resident contacted City of Anchorage Environment, Air Quality Office and was informed no equipment available in Anchorage to test the air quality for hazardous hydrocarbons related to large tarring operation. The Cornerstone Church personnel stated the tarring would be for at least 10 working days. It has already exceeded that time projection and is continuing. Anchorage Air Quality has assigned a case Number 78281 because of the likely violation of city code 15.20.020/8 for soot, cinders, noxious acids etc. emitted in the tarring process. Anchorage Planning and Air Quality offices are to be thanked for their timely response to a resident's concern on neighborhood air quality.
