UAA SURVEY

The Fall 2003 Alaska Justice Forum, a publication of the Justice Center, presented the results from their late spring 2003 telephone survey representing local attitudes toward five key issues: police performance, emergency medical services, public transportation, snow removal, and schools.

Dissatisfaction in the area of public transportation was evident in their findings. A majority of the Anchorage respondents expressed "somewhat" to "very dissatisfied" with the availability of public transport.
