- Approval of treasurer's report: Heather Schrage- \$394.12, picnic donations needed.

• Report and Q & A Officer B Davis attending, not our assigned APD officer. Nothing to report.

Legislative Reports: Q & A http://akleg.gov/

- Senator: Josh Revak: Tyler Newcombe (staff) in attendance as well. Newsletter not sent out, working on it and will send out next week. Legislative session started. Senator Revak is Chair of the Resources Committee, Vice-Chair of Labor & Commerce. Infrastructure bill-working offline with priorities, advocating for our priorities. Unanimous activity started off by voting down legislator bill that would decrease pay to legislators. Capital is open, they have COVID testing available and a masking policy in the building.
- Representative: Calvin Schrage: Represents district 25, Abbott Loop area. Newsletter and report attached to January agenda. Erik Gunderson (staffer) in attendance as well. Reports quick and busy start- Budget is flat and uses one time savings (such as savings on insurance) and one time federal dollars (Infrastructure and COVID relief) that we might not have later. Assumes 1.5% inflation. Unanimous vote in the Senate and then today in the House rejecting pay decrease to legislators. Pay in salary is the same but it was a reduction in per diem for legislators, voted no. Cost of living is high in Juneau and many have two households to support when they go to Juneau. Bills in committee: Voting process/Ballot curing, Funding Early Education, and Political Contribution limits. Working with the Anchorage Muni on energy improvement. Has a Facebook live 1/29 @ 2pm. He sends a monthly newsletter/update, sign up information in his newsletter (Jan Agenda). Questions for Rep- 1) AK Redistricting- He notes proposed maps done really change district 25 much, under litigation now, they are doing all of this on YouTube for the public to monitor. 2) Any info on why the Director of the PFD was fired? This is concerning that the board fired Angela Rodell, near unanimous interest by legislators to find out what is going on, believing a third party investigation was approved today. 3) Oil revenue-PFD funding the state is concerning (should be paid out to the residents) and not fund the government. Rep Schrage explained the PFD fund is not just oil reserve money. Originally designed to use the benefits of oil revenue, then invested these earnings and used these investment earnings to fund the state work. Offer to speak offline about it anytime.

 Another meeting available for comment 2/3/22 5-7pm in Eagle River Town Hall.

 Tentative timeline 2/15/22 proposal, 2/24 public hearings, then Assembly voting on this in March. Will not be done in time for April Elections. May have someone bring up a special election for an additional seat on the Assembly (Vice Chair Constant).

- Green cards/Property tax. Reminder that this is the assessment of property, not the taxes. Assembly will set the mill rate. There is a robust debate about the 2022 budget.
- Legislation requests- the Port of Anchorage is the big ask for \$600 million. \$15 million for Homelessness divided into three buckets of 5 million each. Work on a defined contribution plan for city workers. Urban Safety Corridors- on high incident roads that have high collision rates. Looking at ways to address safety on major thoroughfares such as Tudor Muldoon curve.
- Working on props for development of municipality owned properties. Facilities
 Update- Sockeye Inn-Complex care, Barrett Inn- Supportive housing. Request for
 proposals for the Mass care-we are waiting. These are to be capped at 200 persons
 with a 130+ capacity surge. Anchorage has \$7 million available, but no units
 available now. Hotel/Inns give 90 people immediate housing. This runs at less cost
 than a housing project.
- Assembly member Suzanne LaFrance- Not in attendance

- School Board member: Andy Holleman reporting with Carl Jacobs also in attendance.
 - Review ASD website- look at "Hot Topics" area on site for information on current issues. Bond proposals (now alternate years) This years package going to voters will be \$111 million- \$30 million rebuilding Inlet View, 50's school renovation not feasible, needs to be rebuilt. \$32 million for 90 large commercial grade roof repairs to various sites- this is renovation and major rehabs. \$16 million is Security vestibules/measures upgrade to 60 schools.
 - Question about Abbott Loop School rebuild- believes this could be on the next bond in a few years. This school and Inlet View are the ones that were in most need.
