# Legislative Reports: Q & A http://akleg.gov/

- Senator: Josh Revak: Report for February, Emma from Senator Revak's office reporting.
  - CAPSIS input system- 5 or 6 proposals submitted by Bruce from ALCC to look at funding are a priority for funding March 3rd. One bill SB148 passed and is now on the house side.
- Representative: Calvin Schrage: Newsletter on ALCC February agenda
  - Budget- Governor proposed flat budget. Some increases for 2022. Two dividends proposed; one a 50/50 payment and one supplemental payout. This would be a cost of 2.5 billion, concerning as the states entire budget is 4 billion. Uptick in federal funds and COVID relief and additionally oil prices increasing to \$100/barrel. We should look at this increase in revenue put toward savings and keep downward pressure on budget and spending. House/Senate working in smaller groups looking at department budgets and spending. Four amendments accepted. Redistricting is currently five separate lawsuits, court's ruling and final revisions should be decided by June 1st. HB227 Earthquake and Energy improvements. HB227 Political Contribution limits. HB267 Voting. Question: Stand on Rep. Eastman's removal? Taking this seriously, looking at actions and fitness and looking at fact finding before supporting removal. Question on Solar energy not being effective in Alaska because of winter conditions. I am a believer in the right energy development in the right areas, House Energy Chair. Interested in new opportunities.

- School Board member: Andy Holleman and Tom Roth from ASD-
  - Review of Bonds, 111 million dollar bond package. One third roof repairs and upgrades. One third Inlet View, built in 50's, will have new construction on site in a different footprint, and the school will stay in session during construction. One third Security vestibules in 12 schools, security. Question about "defunding" SROs. ASD does not want to remove SROs but understand that they are city employees, do not

have school assigned duties, and work in the community patrolling and are called to other areas, as well as not at schools in the summers. ASD is asking the Muni to cover this cost, it should come from muni funding. Question: Why are kids not performing and we keep funding? Lots of reasons, many factors and we have a lot of work to do, funding is important.

Want to improve access from two neighborhood areas leading into the park- develop these access points for increased walkability and safer areas. Will work on this for community parks grant. The Parks & Rec Committee will put this on their CIP to get this into the cue. Jon and Dave will help with grant applications and Parks will set up some meetings to get this going.

• Craig Bennett S4 Group and landowner owner Andre Spinelli. Gave slideshow of the area/streets. This is three small lots located off of Abbott Rd, across from Fred Meyer. Owner would like to change the land use designation of the site from Compact Mixed Residential to Town Center and the zoning designation of the site from R-5 (Low Density Residential) to B-3 (General Business District), this would then match the use and zoning designations of property to the south and west of the lots. Another neighbor has sought this same change for two lots behind these three. Muni has declined changing this. One lot is along Abbott. Owner believes this B-3 designation is general business that doesn't exclude housing. Mixed responded for support. Agree that this is the start of the conversation and S4 will send the maps and lots to us for posting in minutes.
