1 Girdwood Brewing Company, LL#5518 2 3 Any ABC Board violations and/or incidents that would lead to an ABC Board violation are attached for the Assembly's evaluation. 4 5 There are no taxes owing. 6 • 7 Anchorage Police Department had no comments regarding the above 8 establishments. 9 Certifications from the Anchorage Health Department, the Anchorage Fire Department, Land Use Enforcement, and the Building Safety Official have been 10 11 received. 12 Anchorage Municipal Code 21.03.040C.4.a states that any use that includes the retail 13 14 sale of alcoholic beverages, with the exception of a restaurant or eating place that 15 sells beer and wine for consumption only on the licensed premises, shall be considered by the assembly. There are special land use permits for all of the above 16 establishments that fall under AMC 21.03.040C.4.a. 17 18 Anchorage Municipal Code 21.03.040C.4.b requires that a restaurant or eating place 19 20 that sells beer and wine for consumption only on the licensed premises, shall be 21 considered by the director of the Planning Department. There are special land use 22 permits for all of the above establishments that fall under AMC 21.03.040C.4.b. 23 24 Alaska Statute 04.11.480 provides that if the Assembly wishes to protest the issuance, renewal, relocation or transfer of an alcohol license, it may protest within 60 days 25 following receipt of the application and the protest will be honored unless the ABC Board 26 27 finds the protest to be arbitrary, capricious and unreasonable. The last day to protest is on or after August 14, 2023. August 8, 2023, is the last scheduled regular 28 29 Assembly meeting before the end of the protest period. 30 31 Approval of this memorandum waives the Assembly's right to protest the application filed with AMCO for the ABC Board for the 2023-2024 licenses for the 32 33 **above establishments.** The Municipal Clerk is authorized to notify the AMCO of the 34 Assembly's action and is authorized to sign on its behalf. 35 36 Respectfully submitted, 37 38 39 40 Jamie Heinz Municipal Clerk 41
