Attached is an overview of my experience with the Homeless Shelter Task Force (Clean Slate Strategy). Let me give you an explanation of my experience.

- . 1. It continues to be an honor to serve you and the other community councils of our area. I continue to do so with any and all upcoming meetings, like the one that occurred on 9/20/23 and 10/11/2023.
 - 9/20/23 Assembly Housing and Homelessness Committee Meeting
 - a. No plans presented by the Assembly
 - Mayors Office has a plan to make a Emergency Shelter at the S.W.S. operation center on 56th. The mayor has the latitude to do an emergency rezoning to comply with the emergency need of the shelter. The shelter could house 150 individuals, be a gated facility with only authorized people allowed, have divisions within the facility for women and men, and have shower / latrine provisions. The facility will be open until 4/30/2024.
 - c. Ken McCarty inquired of three (3) questions:
 - What has been investigated and decided of the feasibility of the JBER mobile dorms (sleeps 12)?
 - · What is being done to secure identification for homeless who would like to return to their village or state of origin but must get through TSA at the airport?
 - What is the interaction with the Federal delegation regarding Federal mandates, which dictate housing number requirements-that are not applicable for Alaska? It is denying people housing resulting in perpetual homelessness.
 - 10/11/23 Assembly Homeless Shelter Task Force Meeting
 - Last Clean Slate Task Force meeting was June 14, 2023
 - b. Contracts are being negotiated to start this week for Emergency Shelters at:
 - Alex & Aviator Hotel 371 beds
 - SWS (Congregate) 150 beds
 - TAY (Transitional Add to Youth Covenant House) 25 beds
 - Emergency shelter beds are until 4/30/23
 - d. Total E.C.S. beds will serve 546 people.

- Informed that there is consideration of a proposed bond to pay for homeless shelter for the April 2024 Muni election

- Emergency Shelters Presented by Miss Johnson
 - Emergency Shelters will be up and operational by 10/16/2023
 - Review meeting 10/18/2023
 - Can process about 20 people per day
- Questions for 10/25/23 Meeting
 - Is a congregate shelter preferred over a non-congregate shelter?
 - How do we not loose control of social norms?
 - What is the results of the Anchorage Coalition on Homelessness Survey?
 - Do we need to revisit the map of criteria of locations, as the SWS facility is not on the current map? How many other potential locations exist?
 - Question of size capability and expense of shelter?
 - Question of one or multiple shelters?
 - What is the exit plan once the need has been met?
 - What is the criteria for homelessness?
 - What is the differentiation demographics of people who have been banned from their village of origin and those who are discouraged from their village but can return?
 - What is the differentiation of multi-family residence usage because of being forced to live by such means and those who choose to live in such means due to economic advantage?
 - What is professional advise from national standardized statistics / data analysis?
 - What is the consideration for shelters in the summer?
 - How is the shelter model fitting with the restorative re-entry model?
 - What is the capacity analysis in addition to demographics?

 - Ron A Desire to respect the audience participation by availing a timer clock to inform the presenter how much time they have rather than interrupting them to tell them they have 30 second, thus interrupting the flow of thought.
