 - October 30-November 4th Anchorage Action Housing Week. Summit on November 3rd at UAA Student Union. Different events throughout the week. See details here
 - Body Worn Cameras- at a Public Safety meeting-got an update. Pilot project to have 30 days/30 cameras- then reevaluated/work out any issues, then on to full implementation. Using a radio shop outside of APD to get the systems going- they can only complete 2/week. Will eb total of 350 total systems when all up and running. Will take time/Asked APD if there is any way to hurry this up.
 - Homelessness- Implementation to plan. Alex hotel 100 beds, as of 10/19

full. Aviator 274 beds as of 10/19, 52% full. Old SWS building/Muni- 150 beds, coming online at some point. Two week delay. Homelessness page on Assembly site here. The Assembly Housing tracker shows what was allocated and how much set aside.

- Meg Zalatel-
 - Mayor's budget October. \$12 million under budget, the savings is from things such as a "labor scrub"- saves \$2.6 million from not filling vacanciesthis closes the ability to fill at a later date, and is not true to what is needed to fill positions in muni. Continues to harm muni. Will finish up soon and bring forward amendments by the Assembly at the 11/9 meeting. SIP Upgrade \$2 million, Safety Center contract \$2-3 million, Reverse labor cuts-restore vacancies. Frontline positions, eliminate funding from loss of positions. There was a \$500k increase in snow removal- checking on how wage negotiations are going.
 - Retention, Recruitment, and Professional development.
 - Priorities are Snow Plan- Snow Summit 10/20- funding! Ensure also not a barrier to housing development. Making sure funding for Mobile Crisis team, police department- for 24/7 coverage. Open public testimony at next assembly meeting. Nov 7th- Bonds for April ballot. Looking per district, CIP-District 4- will review any that are state funded requests. May review putting on the bonds instead. Park Bonds is small- \$2 million range. Public restrooms- putting in public restroom facilities in several areas in Anchorage, this would be investing at the cost of a cup of coffee on to the taxpayer/per \$100k/housing.
- <u>School Board member(s)</u> Pat Higgins- no report, not in attendance.
- Mayor's Office Report reporting by Michelle Hodel
 - Mayor delivered his proposal for the 2024 budget, safety/cost efficiencies are a priority. \$12 million below the tax cap, believe review brought to a good decrease in spending which was \$2.4 million below the 2023 budget. The mayor signed onto an amicus brief petitioning the U.S. Supreme Court to review two recent 9th Circuit Court rulings that place severe restrictions on how cities address homelessness, he believes sheltering is a solution to homelessness. Code changes to go back to pre SB91 status where failure to appear code changes to be made. SWS building-large areas with cots- One common shelter space. Old Seward area, hoping to open November 1st.
