March is the month to call and email all those running for Assembly to ask their position on local issues and to tell them yours. We will have a new Assembly member and none of the four running are fully versed on development problems in our area. We must make all four aware of the impacts that poorly executed development has on existing neighborhoods. They must understand the importance of coordinated planning (the Hillside District Plan), strong development standards (the current rewrite of the Title 21 zoning and building codes) and the sanctity of agreements between the developer and the neighbors as represented by the municipality (subdivision agreements). They should understand the drainage problems we have, the poor shape of many roads, traffic congestion, and then think of the 1,000+ acres that are in the planning stages of development within our area.

You will be receiving mailings and calls from Assembly candidates. Contact them, they will be glad to listen and talk. Write a letter to the newspaper about what is important to you. All of that shouldn't take more than an hour. Spend an additional two or three hours and attend the HALO candidate night Thursday, March 1 at O'Malleys on the Green. It is a good time to listen to all the candidates at one time. There will be a second chance to listen to Assembly candidates and ask questions at our meeting on March 8.

And take the time to contact Chris Birch, our Assembly representative not up for election this year. Ask his position on issues important to you and make sure he understands what you think. His contact info is 346-3265 and chrisbirch@gci.net.

South Side Candidates for Assembly Respond

There are currently four candidates running to fill the vacancy being left by Janice Shamberg: Valerie Baffone, Ryan Stencel, Jennifer Johnston, and Gary Hovanec. The RCCC asked these candidates to answer four questions. While their responses have been edited to fit in the available space, we made every effort to present their answers as they were provided. Quotations are used to indicate the words are their own; otherwise we have summarized from verbal responses.

Question: Title 21 (land use laws) is being rewritten. What do you believe the relationship between the Comprehensive Plan 2020 and Title 21 should be?

Baffone: "I believe that the Anchorage 2020 Comprehensive Plan should be the road map for the Title 21 rewrite....The MOA Land Use Planning ordinances, Title 21 should comport with the Anchorage 2020 Comprehensive Plan."

Stencel: She states that she has in-depth knowledge with regards to the Comprehensive 2020 plan and Title 21. She says that she will "hit the ground running" with experience.

Johnston: Recognizes the development pressures of Rabbit Creek. "The Comprehensive Plan 2020 is a working outline to form Title 21. I understand from John

Weddleton that the Hillside District Plan will supersede Title 21 when it is finished. All three efforts have been done with an extremely well thought out diverse public forum. Consequently there will be elements that we both agree and disagree with."

Hovanec: He is not familiar with the details of Title 21 and the relationship to the Comprehensive Plan 2020 specifically. Instead, he views the big picture of Anchorage development; especially the need for coordination between state, Municipality and private developers.

Question: Do you support the tobacco ban that will go into effect on July 1, 2007?

Baffone: "I will be voting to support the actions of the Assembly last year and not repeal the smoking ban."

Stencel: She does not support the smoking ban.

Johnston: She supports the smoking ban. "Smoking ordinance will be up for validation by the voters in April – while I would not have initiated this proposal I appreciate a smoke free room."

Hovanec: He supports the smoking ban.

Question: When developers damage nearby residences, should they be held accountable for repairs before being given additional permits for new developments?

Baffone: "Developers, like individuals, should be responsible and accountable for their actions. Restraints on future development should certainly be considered if there is a failure to exercise proper accountability for damages."

Johnston: "Depending on circumstances and magnitude of violation", she agrees with accountability before further development is approved. "We need to be careful not to encourage pure animosity between neighbors."

Question: Who do you align with most on the Anchorage Assembly?

Baffone: "I have tremendous respect for Janice Shamberg and am very pleased to have her strong support and endorsement in this race. As an independent and opinionated individual I must say there is no member of the Assembly or the Mayor for whom I agree with 100% of the time. However, in response to your question, Janice Shamberg is the member of the Assembly that I align with the most."

Stencel: She feels that she is most aligned with Dan Sullivan.

Johnston: She is aligned with Chris Birch and Debbie Ossiander. Hovanec: He is not aligned with any assembly person.

- Viewpoint Subdivision
 - Bruce Brown & Anna Taylor consultants with PTI presented plan to subdivide 96Acre into two parcels; 3
 Acres & 93 Acres. The 3 Acre parcel is to be sold to Heritage Land Bank (HLB) to create a possible
 elementary school site for Anchorage School District. Typical elementary school needs 15 acres 3 from
 Viewpoint and 13 from Legacy Point will meet minimum requirement.
 - o Hearing is scheduled Wednesday 7th Platting Board Meeting Case # S11546-1.

- Discussed need for access from Goldenview to Old Seward or New Seward highway through property.
 Infrastructure and traffic concerns were voiced numerous times by RCCC members.
- Mr. Brown did not provide a timetable for development, but there have been meetings with the MOA to try and address the infrastructure, environmental, public access & historical trail issues. The conceptual plan for development has been put on hold to address the infrastructure problems.
- o Mr. Brown stated that believed the request for subdividing did meet MOA Code 2115 and was not asking for variances. Roads were not factored into the request for subdividing.
- o Mr. Brown stated that he believed HLB had a longer planning perspective than ASD when asked why they were subdividing the land for a school that ASD has stated it is not planning for.
- Citizens expressed concern over development in the area without addressing infrastructure/long term plans.
- Land is currently zoned R3 which allows allow for high density development.
- O Discussed need for a collector road at 8% grade to allow for school bus access. Collector roads are typically built with state/federal funding besides developer's funding. Members expressed a desire for a road to be built that would be used by residents to reduce the congestion at the intersection of Goldenview and Rabbit Creek
