- ASSEMBLY-Karen Bronga meeting to reduce anchorage budget, Homelessness: we will not criminalize camping, housing is the solution, but many of the people experiencing homelessness require transition. We need additional 4 million from state to keep shelter operating. Opinion on the east side is oppositional to the Sprung Structure, little remains known. Old Sherwin Williams is a better prospect has showers and sprinklers, it is less expensive to house in existing transitional places than to incarcerate, by far. Legislation is proposed for private individuals and nonprofits to host tents for periods of time.


