4                   **PRIORITIES UPON ASSESSING THE MUNICIPALITY OF ANCHORAGE’S**  
5                   **2025 CAPITAL IMPROVEMENT PROGRAM SURVEY**

7                   WHEREAS, through notice received by Mayor Dave Bronson’s letter dated March 28th,  
8 2024, addressed to the Federation of Community Councils, members of the Sand Lake  
9 Community Council reviewed and completed the 2025 Capital Improvement Program Survey;  
10 and

11                  WHEREAS, the Sand Lake Community Council reviewed, prioritized and completed the  
12 Municipality of Anchorage’s 2025 Capital Improvement Program Survey; and

13                  WHEREAS, Sand Lake Capital Projects are prioritized as follows:

- 14                   Priority 1 – Jewel Terrace Street
- 15                   Priority 2 - Jewel Terrace St. Road and Drainage Improvements (23-08)
- 16                   Priority 3 - Tasha Dr. Reconstruction (20-15)
- 17                   Priority 4 - 88th Ave. Upgrade - Jewel Lake Park to Jewel Lake Rd.
- 18                   Priority 5 - Blackberry St Upgrade - Strawberry Rd to Dimond Blvd.
- 19                   Priority 6 - Greenbelt Dr Area Reconstruction (20-11)
- 20                   Priority 7 - Athletic Field Safety Improvements
- 21                   Priority 8 - Collins Wy/64th Ave/Cranberry St Upgrade - Jewel Lake Rd. to  
22                                   Raspberry Rd.
- 23                   Priority 9 - Caravelle Dr. Upgrade and Reconstruction - Raspberry Rd. to Jewel  
24                                   Lake Rd.
- 25                   Priority 10 - 80th Ave. Sidewalk - Canal St. to Jewel Lake Rd.
- 26                   Priority 11 - Opal Dr. Road and Drainage Rehab
- 27                   Priority 12 – Porsche St. Reconstruction
- 28                   Priority 13 – W. 70th Ave. Extension Arlene St to Timothy St.
- 29                   Priority 14 - West Anchorage Snow Disposal Site (19-01)
- 30                   Priority 15 - West Dimond Blvd Upgrade Phase II - Jodhpur Rd. to Westpark Dr.
- 31                   Priority 16 - Country Woods Subd Area Road Reconstruction
- 32                   Priority 17 - Jewel Lake Rd. Upgrade - Dimond Blvd to North Point Dr.; and

1           WHEREAS, the Sand Lake Community Council requests the following Sand Lake  
2 Capital Projects which are listed in the 2025 Capital Improvement Program Survey to be  
3 categorized as “Unassigned Priority”:

- 4           • Northwood Dr Extension - 88th Ave to Dimond Blvd
- 5           • Tony Knowles Coastal Trail Erosion
- 6           • Multi-use Trails and Pedestrian Bridge Upgrades
- 7           • Campbell Creek Trail Rehabilitation and Wayfinding
- 8           • Fish Creek Trail to the Ocean (Fish Creek Trail Extension); and

9           WHEREAS, the Sand Lake Community Council requests the following Sand Lake  
10 Capital Projects which are listed on the 2025 Capital Improvement Program Survey to be  
11 removed from the survey list based upon the fact that they are not located within the zone of the  
12 Sand Lake Community Council:

- 13           • Fish Creek Trail to the Ocean (Fish Creek Trail Extension)
- 14           • Campbell Creek Trail - Separated Grade Crossing @ Lake Otis.

15           NOW THEREFORE, be it resolved that the Sand Lake Community Council requests the  
16 Municipality of Anchorage to enter into record Sand Lake Community Council’s highest Capital  
17 Project community priorities, unassigned priorities, and projects to be removed as stated in detail  
18 in **Exhibit 1** (attached) outlining in further detail each Sand Lake Capital Project provided by the  
19 Municipality of Anchorage survey.
