session or hearings since then, only a technical session has been held.

- In a 4th special session-update dividend formula, will hear a bill from Rep Snyder, will continue to make progress towards a fiscal plan, ways and means committee meeting
 - Bills become law after 60 days without signature from governor
 - This will likely be least costly session, first 3 special session were 1.3 million dollars in total.
 - There are lots of proposals to update the Permanent Fund dividend formula. The nonpartisan legislative financial analyst has looked at each one to determine their impact on the budget. See for

Assembly Report:

• Assemblyperson Dunbar and Petersen:

- Rezone on the agenda, property for DeBarr Road (Roller rink) to go from residential to mixed, approved by PnZ.
- Revenue update today 3.3 million for PFD garnishments for the first batch, and perhaps will collect another .6 million later. Room tax came in stronger, same with rental car tax and APD counter fine (eg, speeding tickets), 2021 revenues are about where they were projected to be.
- First budget hearing on the 27th or Tuesday, November 9th. Open to testify.
- Mask mandate passed a week ago, encouragement to wear a mask especially coming into the winter season where people spend more time indoors.
- First work session on the operating budget tomorrow, can be observed. Public hearings are the dates above. On November 23rd the budget will be voted on or amended. There are 3 budgets:
 - Enterprise or utility
 - Operating
 - Capital
 - There is a 6 year capital plan. This is where the bonds are, the
 projects have been taken out of the bonds for east Anchorage at
 this point. RJSP did a resolution to bring the funding back to the
 bonds for the projects (money was for Chanshtnu, Russian Jack
 and ball field updates).
 - Encourage members to make a request to put these items back on the bond as well as advocate for the park projects.
 - The most pressing projects: -\$500k for Russian Jack Springs Park
 -\$200k for Chanshtnu Muldoon Park -\$500k additional funding for Traffic Claming -\$250k for athletic fields
- o Voting on homeless resolution and sites on Tuesday, 2 are close to East side.
- The Chief Equity Officer was illegally fired, and the assembly sent a letter to the mayor. Bob Dole also resigned, current lead of mass care (Shawn Hayes) was fired today, article in ADN.

 - Brown Jug Whaler transfer from Peck Ave to 530 Muldoon
 - From Whitney Hillman representing Brown Jug: The transfer would be moving the current license and not creating an additional location. We are investing into the East Side community and will be significantly improving an older existing building, and moving from a rundown location. We were unable to come to terms with revamping the current storefront. New location would be fully remodeled and refurbished, will be lit, and secure with a Patronscan system. A Patronscan system is an exterior wall mounted scanner which only unlocks the door when a valid ID is scanned, thus creating a safer place for customers and employees to shop in our store. Please feel free to reach out with any questions or concerns. I know that we are working on creating a safe parking environment. (Currently Aaron's/billiards place, stand alone building, end of the strip mall, northwest corner). Our Tudor and Elmore location currently utilizes the PatronScan if you have been to that store.
