**Meg Zaletel** Following up on recent stakeholder hearings, the Assembly will be acting on the 1991 Eklutna Fish & Wildlife Service settlement proposed by the electric utilities. A proposed e-bike ordinance is deferred, pending a rewrite, until second assembly meeting in July. The Home Initiative is up for a public hearing. The new version would allow duplexes and more than one primary structures in all residential zones. There will be discussion of funding for the 56<sup>th</sup> St. shelter, pending possible state funding. There will be discussion of an accountability board for Childcare and Early Education Board, as funded by the marijuana tax.
