From Senator Tobin's office:Session Update

We anticipate that the omnibus education package, Senate Bill 140 will be on the House Floor next week. Senator Tobin along with two other Senate majority members have been negotiating with House members to address severe underfunding of our public schools and come to some agreement on reasonable education policy.

In Senate Health and Social Services, SB 115 regarding physician assistants' modernization will be heard again on Thursday where we anticipate it will move forward in the process onto Senate Labor and Commerce. Brian Injury Awareness Month (SB 46) has been passed out of House State Affairs and we anticipate that

bill will be voted on the House Floor soon.

Our office is monitoring the STIP process – we have been aware of the continued issues with this incredibly important document and are communicating with the Department of Transportation to get Alaskans federal transportation dollars we rely on. We will continue to work with the department to ensure close adherence to federal regulation and encourage best practices in multi-modal transportation. We have also been in communication with the Department of Transportation regarding snow clearing, and we want to give a shout out to the constituents who have advocated to our office for improved snow clearing on sidewalks. Senator Tobin would like to continue to stay in contact around these issues, and additionally we are encouraging constituents to report facilities issues via the Title VI/Americans with Disabilities Act (ADA) complaint form (linked here).

Personal Legislation

SB 27: Contraceptive Coverage (Ability to receive 12-months of birth control).

SB 46: Brain Injury Awareness Month (AK has the highest rates of traumatic brain injury).

SB 100: Access to Marijuana Conviction Records (expunging marijuana violations from court view from before personal use was made legal).

SB 101: Renewable Portfolio Standards

SB 109: Employee Rights and Employer Speech (prohibits an employer from requiring an employee listening to employer personal beliefs of opinions in a captive audience meeting).

SB 115: Physician Assistant Scope of Practice (improving patient care and access).

SB 229: Allows family members or law enforcement to petition a judge to remove a firearm from the environment of a person deemed at risk of harming themselves or others, also known as red flag laws.

Discussed and voted on next meeting:

WHEREAS, Valley of the Moon is a valued park providing access to playgrounds, trails, picnic shelters, a dog park, and the Chester Creek trail for residents of North Star, South Addition, and other neighborhoods in the Chester Creek corridor; and

WHEREAS, the 2015 Valley of the Moon master plan encouraged continued activation of Valley of the Moon with non-motorized activities including bike and pedestrian trails; and WHEREAS, access to parks and trails is important for all neighborhoods in Anchorage, particularly for children and families who have limited access to automobiles and should be able to access parks by foot or bicycle; and

WHEREAS, the Municipality of Anchorage planned on constructing a pump track at Tikishla Park, but eliminated that portion of the project late in planning, and there is not currently a pump track in walking or biking distance of neighborhoods including North Star, South Addition, Forest Park, Downtown, Fairview, Rogers Park, and Airport Heights; and

WHEREAS, pump tracks are an increasingly common park amenity in communities across the country, and have proven to be very popular at Mirror Lake and Chantschnu parks in Anchorage; and

THEREFORE BE IT RESOLVED, the North Star and South Addition Community Councils are acting as sponsors submitting an Anchorage Parks Foundation Challenge Grant application, and request the support of the Municipal Parks and Recreation Department and Anchorage Parks Foundation to complete this project.



New Approach to Housing



The biggest barrier to housing in Anchorage is finding affordable units.

What if the system bought its way into the market?

What if landlords received supports along with people experiencing homelessness?

What does that look like?

THE NEXT STEP

- ✓ **Data:** Use of the Coordinated Entry housing needs assessment to match people with housing that is right for them.
- ✓ **Equity:** Shift to person-centered approach that identifies inequities in the housing system.
- ✓ Funding: Braided and leveraged funding to support housing.
- ✓ Coordination: Working with partners to identify high priority individuals as well as assets and barriers to housing.
- ✓ Housing: An acquisition strategy that works with landlords to identify units and provide supports.
- ✓ Supportive Housing: Streamlined process to access permanent supportive housing.
- ✓ **Support Services:** Diversified funding and a case management strategy to overcome workforce challenges

Next Step in action: More housing means less need for shelter

The NEXT STEP PILOT gives us a roadmap to quickly and sustainably move people to housing, creating flow in emergency shelter and other homelessness response services.

This financial model is the all-in cost for housing 150 individuals assuming no subsidies or outside contributions.

\$100 a day
Per person cost for shelter

\$85 a day
Average per person
cost for housing

How do we pay for it?

The NEXT STEP is a public-private partnership model that uses existing investment in new ways coupled with individuals accessing subsidies and other person-centered supports.
