

E-Board meeting started at 6:30 pm.

Attending: James Thornton, Allen Kemplen, Sharon Chamard, Lindsey Hajduk, Kelly Ittenbach

Zoom: Mikea Fulton, Karlie Lamothe(Planning Department, Municipality of Anchorage)

Karlie : One of our projects is to implement the MOA All-Hazards Plan into existing neighborhood Plans using funds from the Community Development Block Grant for Disaster Relief (CDBG-DR). Taking natural and technological hazards into account in land use planning will help mitigate the risk to residents of Fairview as the community grows and changes over time This Disaster Recovery block grant was awarded following the 2018 Cook Inlet earthquake.

*Allen: Are you familiar with atmospheric rivers? Will want to make sure this is incorporated in this plan.*

*Karlie: yes. Severe weather is included in this all-hazards plan.*

*Allen: Can we set up a separate meeting to talk about opportunities for cooperation?*

*Lindsey: Seeking consulting team for Reconnecting Fairview planning effort. Would love to integrate this into our effort, especially the demographics information.*

*Karlie: We have the latest census information to share. We're here to be a resource.*

*Sharon: Does hazard mitigation include disaster preparedness?*

*Karlie: Yes, but this plan is not as updated as disaster relief plan Some things will defer to the disaster relief plan because it is updated more often. This plan calls out community resources and potential temporary emergency shelters.*

*Allen: One thing advocated for in the past by the municipality and agencies is that we need to establish neighbor response leaders who are trained to provide assistance during a disaster to take overflow from the disaster response shelters.*

*Karlie: That's not in this plan. It may be in the EOC policy. Can be a Fairview specific hazard mitigation action plan.*

*James: Thank you - It's obvious to me that the planning department too special consideration to the Fairview neighborhood when you brought this up as an opportunity. Let's schedule a follow up meeting. Maybe end of October?*

*Agenda Items:*

*James: Hope CAP team will be at the meeting.*

*Allen: Have In Our Backyard come to November E-Board meeting.*

*Sharon: Wants to change bylaws for treasurer's report to be reported quarterly instead of monthly.*

*Discussion about Resolution 2024-12: Shadowing of Town Square and importance of height restrictions, density, and height restrictions. Re: Planned Unit Developments (PUDs): Have to give opportunity and time for folks to participate. Need informed consent; need to be cautious when planning these big changes.*

*James to designate Allen as project lead of AARP Grant.*

*Conversation about Henning and Rocket Fuel Program.*

*Conversation about 15th Ave signals and kids walking to school. Creates unsafe and negative impacts to safety of kids if they have to wait so long to walk to school and have to walk in the streets during the winter because of lack of snow removal. Perhaps should talk with Fairview Principal about this.*

*Allen will introduce a resolution to encourage municipal departments to include Fairview Greenway on their bonds. Also, will introduce resolution supporting staff recommendations of council boundaries.*

*James: looking for template resolution from Spenard Council about pedestrian safety.*

*Resolution 2024-13 (5013C status): Sharon will work on it more.*

*James: reached out to Parks and Rec. about Orca Street damage.*

*Allen: Met with Dan and neighbor. Provided recommendations; took photos. Perhaps put up a bollard.*

*James and Bryan reached out to Emma Hill re: email and shooting problems.*

*Sharon: Clever that she she publicized problem on Facebook.*

*Allen: She could introduce resolution that council should go on record as supporting enhanced approaches to mitigating gun violence in the municipality. The action shows that this is not acceptable. Encourage her to come to council meeting and use the process to channel her concerns in a productive way.*

*Sharon: She needs to figure out who used to live there and contact all of them to find out who is shooting at them. Perhaps this problem stems from someone who used to live there.*
