## 4. Officer's Report:

- a. Treasurer as of September 13, 2024: Checking account balance is \$1,561.15 with \$.14 interest for July & August
- b. FCC Delegates Presentation on "Demystifying Community Councils: Understanding Their Role in Civic Engagement"

## 5. Representatives/Community Reports

- a. Assembly Member Randy Sulte presented the 2025 CIP List; AEDC Project Anchorage; the alcohol plan and how to use the tax funds collected; AWWU and the Eklutna Dam 2024-2026 about decoupling of the water supply due to the 1991 agreement, how-to restore to the Eklutna River, how it will impact Anchorage drinking water, and stored hydro power; short-term rentals like VRBOs to provide certain data to the MOA; scrap dealers of catalytic converters tracking them and how-to go after the criminals; APD needs \$5 million for repairs and maintenance on their cars; Varina is the contact for Housing and Homelessness committee with the Assembly; plans are needed for convicts coming out of jail and teenagers experiencing homelessness; the Solid Waste shelter will be used to house the homeless this winter; the Municipality is paying for hotels with 3 meals per day and tv with requirements to help like a hostel; unhoused means living on a couch, kids too; Catholic Social Services program pays rent for a month so they are not on the street; winter is coming. Questions for Randy included snow removal, APD's fleet of cars are older and repairs; \$5K month for housing; buildings that may be sold; the Navigation building and repurposing it.

- d. APD -Alaska Highway Safety Office \*\*\*Unavailable
- e. Alaska State Senator Cathy Giessel by Paige Brown Cathy is working on energy solutions for Cook Inlet and establishing an energy authority; the Bradley Lake project; and bills that were passed into law to expand the supplemental nutrition bill.
- f. Alaska Representative Craig Johnson Outlined legislative business; assisted with the Mary Ave, \$2 million grant from the State of Alaska for gutters & pavement but no sidewalks.
- g. ASD School Board member Carl Jacobs filled-in for Kelly Lessens Seven people will swap every year going forward. Working on the "Right Sizing Plan" student enrollment is down, population is in decline around Anchorage; there's no long term fiscal plan yet; educators are not moving here; Elementary schools are at 50/70% capacity so there may be a multi-year closure plan with program consolidation; Charter Schools may get a school; Proposition 14 to use marijuana funds for childcare programs in schools with free or a reduced cost for teachers; school policy amendment for anti-bullying with 2 times notification per year and anonymous reporting; considering revision of civic and patriotic recitations like Pledge of Allegiance daily and Junior ROTC in the schools. Questions asked: How to get list of raw land and buildings owned by the school district; building homes on the land; the amount of school district land available for future use; and an Inlet View school update.

### 6. **Committee Reports**

- a. Old Seward/Oceanview Community Patrol -- Jeff reported that an abandoned camp in Oceanview Bluff Park was cleaned-up; sixteen year old Mason is still missing and are asking you to reach out to APD or his family if you have any information about him; thefts during summer in Oceanview; people wandering around checking vehicles, some on foot, autos, bikes; neighbors with cameras should contact each other; there was an attempted break-in at a Botanical Gardens home during the day by 2 young men, but a teenager who was home with their big dog drove the guys off; watch-out for your neighbors; it's getting dark so before going to bed check that your garage door is down, vehicles locked, and take your keys to bed with you to use the panic button to sound your car alarm; turn on your outside lights so the Community Patrol can see if people are around your house; more thefts are going on around Pettis Ave. and Mary Ave; mail thefts are going on and don't leave the flag up on your mailbox; check out the Community Crime Map by zip code in Anchorage by using the LexisNexis Community Crime map to identify problem areas; as winter comes crime activities change; more people are following FedEx, UPS, and USPS trucks to pick-up your packages; Huffman and O'Malley are dark areas as well as some areas of Oceanview when there is no moon.
- b. Eldon Subdivision WDID and LID presentation by Joe In 2006 the project started with neighborhood champions; the cost of installing water and sewer is \$130K to \$150K per lot; they worked to get petitions signed for Eldon Subdivision; Senator Murkowski, her staff, and Senator Geisel helped to get a \$2.2 million dollar grant; in 2023/2024 Senator Giesel went door to door and listened to everyone in the subdivision about safety, health, and land issues; AWWU staff met to start putting the project together, which goes to assembly on October 5, 2024. 2025 is the estimated time to start construction. If project costs are higher than the grant funds, property owners will be subject to an assessment.
