Legislative Update: Sen. Loki Tobin & Rep. Cliff Groh

Sen. Tobin:

Post election the senate is again forming into a bipartisan coalition

Knik Arm tunnel – unsure how to approach DOT – is this study the remaining money left over from the Knik Arm Bridge efforts?

Exchange between residents in chat

- Question to Bob French: I had thought all the money had been spent. Was the a million left behind?
- Response from Bob: I don't know how the original KABATA fund have been allocated. I believe that Gov Walker's 2014 freeze on the Bridges was overridden by Gov Dunleavy, but don't know how much \$ has been spent, or might be left.

Gambell Ingra corridor options are out for public comment until mid January.

## Rep. Groh:

From Sen Tobin as Rep Groh is unable to attend:

Disturbed about the reappearance of discussions about a Knik Arm crossing Will be holding the January listening session even with the new election results

## **Assembly update: Dan Volland**

- The Assembly passed Mayor LaFrance's budget for the coming fiscal year. Budget includes
- increased snow plow driver pay and enhanced snow communications for residents. The Mobile Crisis Team expanded to 24 hours, which allows the MCT to bill Medicare for some services. Full funding for the Anchorage Safety Patrol, and approved funding for various homeless services.

### GOVERNMENT HILL COMMUNITY COUNCIL

- Parking is now free downtown for handicap vehicles
- AMATS policy committee today Volland moved to remove "Safer Seward Highway" from the MTP highway plan due to unknown funding sources.

### Port of Alaska: Steve Ribuffo

- Asks for feedback on the new lights at the Port, GHCC President reports no complaints.
- Petroleum tankers are about to start using the cement dock fuel lines have been certified for aviation gas. Tankers are usually tied up about a day and a half.
- Received \$50M grant from Feds to go towards first cargo dock.
- The Port has included the fence for Tract J in its budget but the Assembly may need to
  weigh in about the land transfer as authorized in previous Assembly actions. If the Council

### **ASD School Board: Dora Wilson**

- Reports on the ASD right sizing schools with Anchorage decline in working age demographic ASD has less kids and is looking at closing schools. The school closures will be introduced for action at the 12/3 ASD Board meeting and will vote on recommendations on 12/17.
- ASD decided not to roll out the full Academy programming for high schools. For now, it is only for freshmen.
- The school closures will not effect GH Elementary it is not slated to be a receiver school.
- Resident comments/questions: What is the effect of homeschooling on the school closures? Questions about Inlet View rebuild and previous low enrollment numbers for that school.



- Getting to zero deaths on city roads.
- Safe systems approach all of us are responsible for looking out for each other
- Safer people vehicles, roads, speeds, and good crash response. Reduce lanes for sidewalks and snow removal? Reducing speed limits? Looking for neighborhood feedback.

**Comment from residents** – Extensive comments about speeding on the bridge, walkability, and the danger of pedestrian and bicycle routes along E Loop, the hill, and the bridge.

## Introduction of Resolution 2024-005 re: council boundary

- Resolution will be introduced at January meeting.
- GHCC was asked to comment on decennial review of Community Council borders. Major changes proposed is to take the western edge of the boundary and extend it to median low tide from median high tide lines.
- Other possible changes:
- Adding the small boat harbor to the GHCC. The south boundary is Ship Creek which
  currently makes the facility a part of the downtown community council. Discussion
  indicated support for inclusion with GHCC, that it makes sense to include the small boat
  harbor with JBER and Port. GHCC President will confer with Downtown CC President about
  possible change.
- Also some discussion about including Mountain View section 14, a mostly industrial area.
   No sense of the Council was reached
- Bob French and Peggy Wilcox will draft a resolution after Jody hears back from the downtown community council on their thoughts about the small boat harbor.

## Deidentified and lightly edited chat from meeting RE: DOT safety

• Separation is key

- Tinted windows are very problematic as a pedestrian or cyclist, you can't make eye contact with the driver
- Report a Safety Concern
- Is the one in Mountain View a greenway?
- What about taking a lane of E Loop and converting it for bike/ped use?
- Huge HUGE community blowback on red light cameras. It was ugly. But now that they are much more common in the L48, maybe folks might be more accustomed to them.
- There is a HUGE problem in this community with red light runners. I personally know two people whose cars were totaled by red light runners just within the past 2 months.
- Many intersections have cameras that can record red light running?
- Could we also look at some sort of greenway that give us a connection to the multiuse trails (Coastal Trail, etc) from Government Hill
  - They're working on it with the parks & rec plan over the next couple of years. Along with a dog park!
- It is so narrow two bikes can't pass each other!
- And many wear headphones and you can't pass, that's just a struggle anywhere though, but the tightness sure doesn't help
  - o Agree!
  - Sing it sister!!!! The headphones are a real thing.
- The light at the top of the Hill is also very dangerous since people driving up the Hill take the right hand turn on to Hollywood without regard to whether there are pedestrians trying to cross
  - o Yes true
- That is NOT a 2-person bridge
  - o lecho you 100%
- It is all about maintenance! And the lack of money for maintenance versus spending millions on feasibility studies for the Knik Arm Tunnel
- Thank former GHCC president Stu Hall for the "move left" signs on the bridge near where the Port trucks merge
- Imagine how wide the road will be once they build the tunnel to Pt. McKenzie
