Focus this year: paid family leave, mental health screenings in public schools, free school breakfast and lunch to low income students, women (or men) in prisons who are primary caretakers - maintaining connection with kids, end shackling women to the bed when giving birth in prison, allowing for mother/child bond, strip searches of inmates, monitoring in dry cells, only being monitored by men. Assembly Report - Felix Rivera - Officer involved shooting on Northern Lights - attempted robbery, rounds fired when the suspect fled the scene. Fish Creek Trial Connection - last AMATS meeting, project not on hold, continues to move through process, DOT has approved funds and funding increases. Criminal Activity around encampments - need specifics of the activity and locations. Delay on sales tax proposal to a special election. Five different versions available for review on Muni website - Project Anchorage. Tax Levies Approved - police and ARMSA fleets - systematic tax levy to create known budget for maintaining vehicles. Jed Smith - is the online portal the best way to report homeless camp activity. Answer - yes. Matt Duncan - spoke out against sales tax because it hurts the poor. Answer - Continued public hearing on March 4th about the proposals for sales tax. Need to report difference between residential property taxes and commercial property taxes along with percentage of changes. Will - limitations to what the Assembly can do in relation to taxes, there should be a discussion at the State Law level. 	Lisa Keller - Rep. Irene Persson-Gambel - combining the public and private resources to have muni support for vehicles like Uber/Lyft to provide the connections between the bedroom communities and center of town.
