Letter from the Chair

Issues in front of the Council have slowed down for a bit this summer. I guess developers are busy developing, people take vacations, and who really wants to do paperwork when the flowers are blooming? But the issues do not go away and new ones come on the horizon.

Monday, August 6, the elderly housing at the south end of Goldenview Drive, Legacy Pointe, comes in front of the Planning and Zoning Commission for a site plan review. It is <u>very</u> important that all those who have an opinion on this matter contact P&Z. Many of us will show up at the Lousacc Library that evening to testify or at least make our presence known. To email the muni planning department with your opinion go to www.muni.org, planning department, cases on line, case 2006-142 in Rabbit Creek Community Council area.

Several of us met with Mayor Begich and staff about Prominence Pointe earlier in July. The Mayor has been helpful ensuring proper infrastructure but is mindful of private property rights. We seem to disagree with him as to what some of those rights are including the right to build private residences on land zoned for public institutions.

Two new issues are moving our way. The HLB (muni land bank) is proposing to divide part of Section 36 north of Bear Valley. This is an issue that has festered for well over a decade following a judicial ruling that the entire section should be made a park. It goes before the Platting Board on September 5. Also, AWWU has released a proposal to re-begin the process of water tank site selection.

- David Whitfield MOA Zoning Code Enforcement
 - Lions Club Building has been investigated and currently does not have any zoning violations. The property is in litigation over ownership. The Property Appraisal Department will be reviewing the case.
