36th & MacInnes traffic signal

The light will be going out to bid for signal installation within the next month and into the fall season. The bid process will be simultaneous with the bid for a signal at Providence & Spirit Dr. It takes about 6-8 month to get a pole ordered and arrange placement (sometime in the spring), and should be installed and functional by July of 2010. This is a delay of approximately a year from the last time frame the council was given. The delays are in part due to municipality right of way issues that were previously unresolved, however that has been addressed.

- Liquor Licenses
 - o Those due for renewals within and surrounding our council area are listed on page 2
 - o Council member are requested to review the listing
 - o TACC may request a public hearing before the assembly on any renewal *within our boundary*. If we have concerns about the renewal of a liquor license outside our boundary, we would need to communicate and coordinate our efforts with the appropriate council area
 - O Any council member having concerns about any of the licenses due for renewal shall notify the chair or any other board member and the matter shall be added to the agenda for discussion at the October meeting. If the concern is regarding a license within another boundary, the issue should be brought forward immediately for discussion to allow adequate time for the appropriate council's board to be notified
 - o Requests for an assembly resolution as provided in AMC 2.30.120 subsection D made by a community council under this section shall be made by no later than October 15 of that same year, and shall be submitted to the assembly as part of its packet before action is taken on those renewals. Holders of licenses for which a public hearing has been requested shall also be notified by the municipal clerk of the request for a public hearing.
