NECC November 18, 2004 Motion (7):


*The NECC requests the Office of Community and Economic Development research grants for the Northeast Anchorage area based on the high density of low income population in this area.*

Re: low-income, child-based, or elder-based block grants

Dear Ms. Michaels,

We are working in accordance with the Anchorage 2020 Comp plan to develop neighborhood plans in the Northeast community council district, which encompasses 25,000 people. Some of our neighborhood planners are encountering problems related to poverty, transience, unemployment, neglected children, disabilities, and dependent elders. We need special funding to implement plans addressing neighborhood problems of such proportions.

We ask that the Community of Economic and Development give our low-income neighborhoods the same consideration and funding given to low-income neighborhoods in Mt. View and Fairview. According to the 2000 Census, some of our northeast neighborhoods are in Anchorage's lowest income bracket with a disproportionately low number of 30-50 year olds, which are the highest earners. For these reasons, we request that you provide us information on available block grants targeting problems related to low-income, child, and elder populations.

We look forward to working with you to plan solutions for our neighborhoods.


Re: vacating platted roads in PL1 zone of Nunaka Valley Parks

Re: Maintenance of Valley St. Park

Dear Municipal Planner:

In an effort to develop a neighborhood plan for Cherry-Rangeview Neighborhood, we note that Valley St. Park is listed as nonmaintained. This Chester Creek Greenbelt park through which 50-100 people pass daily, including schoolchildren, requires maintenance and your paperwork should recognize this reality. Please list Valley St. Park as a maintained park.

Further, residents would like an explanation for the removal of the "polluted" sign by the creek in May 2004. We are unable to obtain water quality reports from Watershed Management. Please provide the water quality reports and a copy of the order to remove the "polluted" sign from the easternmost entrance of Valley St. Park by the pipe from which Chester Creek emerges from underground.

We look forward to working with you on the improvement and maintenance of our neighborhoods.
