Meeting Minutes Summary November 5, 2009

**I. Balto Seppala Boardwalk Plan Update.** Suzanne Little from the Municipality Parks Dept gave the update. The TCC Subcommittee has been working on a plan for a trail to link Balto Seppala and Lloyd Steele Parks. AWWU pipes in the area dictate that no structure with a foundation is planned. Walkway will be less than 12" above ground level. Path will be a combination of light-penetrating boardwalk and gravel. The project will be looking for volunteers – please give your name and number to Cathy Gleason or Frank Keen if interested. A resolution in support of the plan will be presented at the December meeting.

**II. Lyn Ary Master Plan Draft Available for Review** A draft Lyn Ary master plan is available for comment on the muni website. Suzanne Little has worked with the community group to come up with the plan. Many community members have invested a large amount of time and energy into this process. Once the Plan is approved by the Parks and Recreation Commission it becomes the official document for the park. Any future proposal will be judged against the master plan. Those attending meetings have provided input. Municipality is looking for final input. The plan says that basically most people like the Park the way it is. The plan provides limits of change. For example: no concessions and picnic shelters. The plan has been mailed out to the TCC Subcommittee members. A lot of work has been done. In December, the TCC we will be voting on a resolution of support. Historical monuments (interpretive signs) will be installed at the top of the hill. The plan says nothing regarding Susitna View Court. Members at the meeting made the suggestion to add bollards to the end of Susitna View Court.

**III. Elections.** The following members were elected for 2010: President: Breck Tostevin, Vice-President: Patrick Kelly; Secretary-Treasurer: Barb Jones; Board Members: Cathy Gleason and Chris Habicht.

**IV. Knik Arm Crossing.** TCC heard presentations for and against the proposed Knik Arm Crossing.
