- A motion was made by Breck Tostevin and seconded by Dan Gleason to approve TCC's March 3, 2011, meeting minutes. Motion passed unanimously.
- A motion was made by Barb Jones and seconded by Steve Strait for TCC to submit as a comment to the Municipality Planning Department that the time allowed from the publication of the West Anchorage District Plan Public Review Draft throughout the comment deadline is not sufficient for TCC to adequately review the Plan and prepare meaningful comments on over 200 pages, which covers land use recommendations for the next 20 years. Motion was passed unanimously.
- A motion was made by Barb Jones and seconded by Dan Gleason to request an extension of time for public comments on the WADP from May 27 to June 10 to the Municipal Planning Department. Motion passed 7 in favor; 1 opposed.
