Legislative reports:

Flynn: Met with Lottie Michael- Southeast corner of lot available for rent for a cafe. Saturday September 10- 25th anniversary of new loussac library 1-5. Sunday 9/11 firefighter's recognition of 9/11 5th and A. Budget proposal due next month. Rumor is the mayor is seeking 4% reductions across the board. MuniBudget.com (or org). Liquor license conditional use permits are up for review and comment by community councils. State Redistricting Plan: Assembly reapportions after the state. Rotating second representative to be moved. Fairview needs more representation. Suggests that Fairview write a letter requesting that the scope of work amended to reflect the permanent noise issues.
