Legislation

I will continue to work to get my two pieces of procurement legislation passed. <u>HB 204</u> - clarifies the Alaska business license requirements for competitive sealed bids and proposals, and qualification for the Alaska bidder preference. This should reduce the number of bids and proposals the state currently disqualifies on technical grounds. HB 204 would also allow for online filing of bids.

The second part of the procurement revision is <u>HB 205</u> - which makes application of the preferences uniform. Currently, preferences do not contain the same language so they must be applied differently. It also clarifies which preferences are cumulative and those that may not be combined. HB 205 would also consolidate the preferences outlined in the procurement code into one section of law. They are currently spread out in different statutes.

I believe HB 204 & 205 will streamline the procurement code to ensure consistent application of the law, resulting in a more understandable efficient procurement process for the state's business partners as well as employees who conduct procurements. These bills passed the house in 2011 and are currently in the Senate State Affairs Committee awaiting a hearing.

I had a constituent approach me, expressing concern over individuals who drive with certain medical conditions and could be placing others at risk when they get behind the wheel of a vehicle. HB 149 - would provide immunity for a person who reports individuals who have a medical condition that may impair their ability to operate a motor vehicle. This bill provides for confidentiality for those that choose to report individuals to the Division of Motor Vehicles. This bill was hear and held in the House State Affairs Committee.

I am honored to serve on the Alaska Statewide Suicide Prevention Council. Last year, I introduced <u>HB 21</u> - which would add a member to the council. Unfortunately, suicide among our military service members is on the rise. This new member would have experience and knowledge working with our military men and women to help address the issues they face after returning from war, and bring a much need perspective of the challenges our service members experience on a daily basis. The legislation would also allow the youth member of the council to serve past the high school level; currently, this member would be required to resign upon graduation from high school. This will provide more continuity in the position and to the board.
