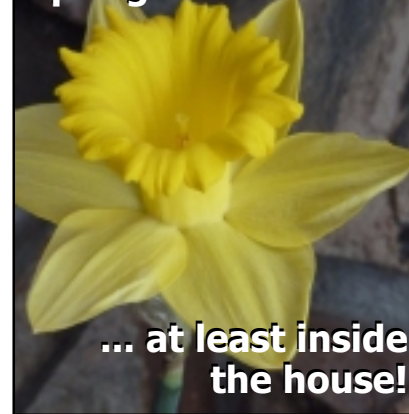

### The Airport is updating its **PART 150 NOISE STUDY**

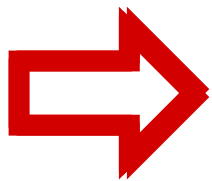
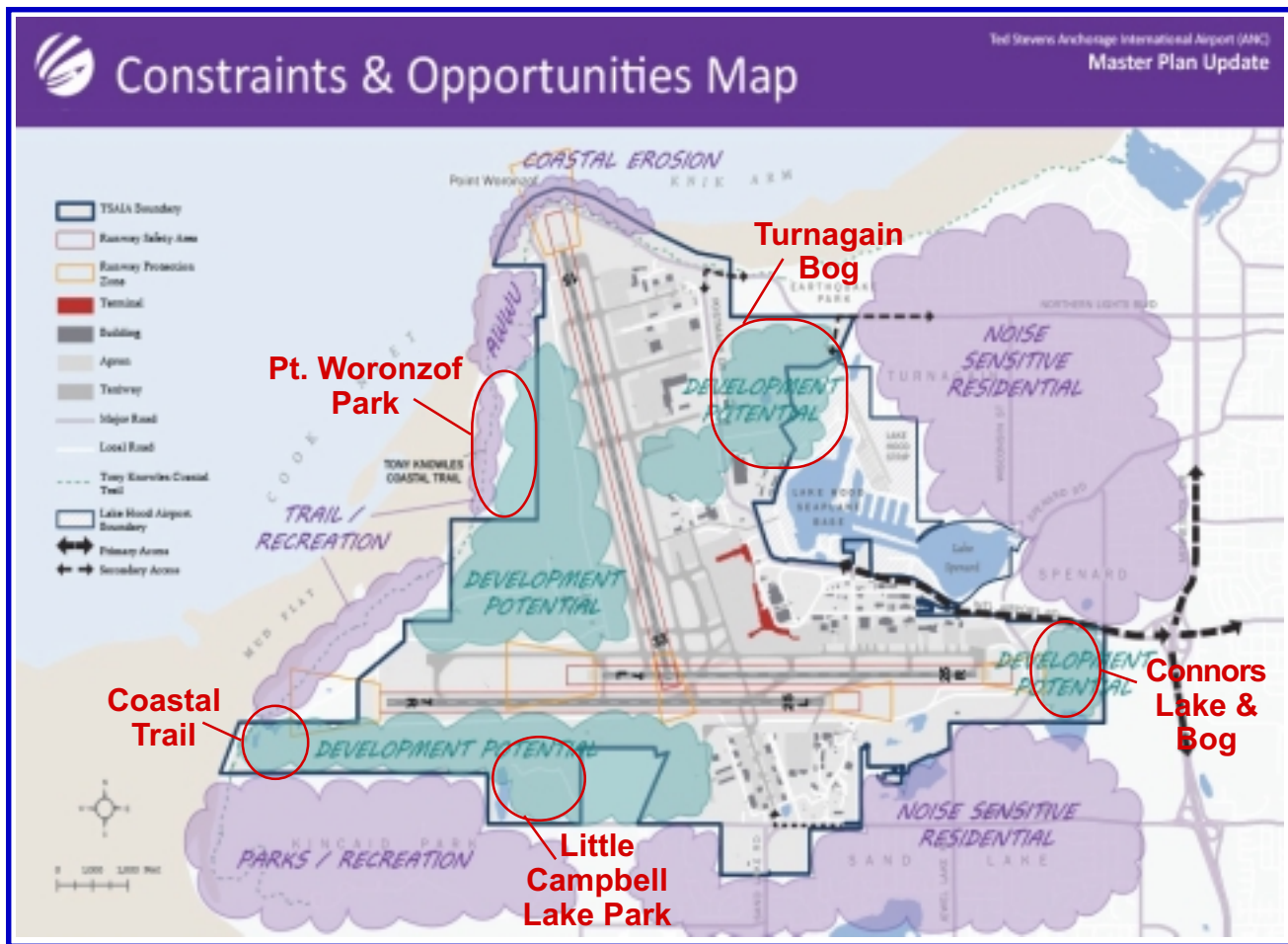
