## • New Trail & Interpretive Signage at Earthquake Park

In mid-June, staff from the Youth Employment in Parks program also built a trail through the wooded area north of the Earthquake Parking lot as part of an effort to view newly-installed interpretive signage highlighting the 1964 earthquake and its impact on this area. #### WNL Blvd. & Arlington Dr. Intersection Drainage/Paving Improvements

Drainage and repavement improvements at the intersection of WNL and Arlington Dr. were made in mid-June, as part of the Northern Lights Blvd./Benson Blvd. Road Improvement Project. TCC approved this project as part of the Safe Routes to School Capital Improvement Project list at our February 5, 2015, meeting. <u>Special thanks to Sandy</u> <u>Rabinowitch and Gloria Manni for their effort to get this project incorporated into the larger DOT project.</u>



#### Aircraft Hanger Project Proposed in Turnagain Bog

The U.S. Army Corps of Engineers released a wetland fill permit application June 23<sup>rd</sup> for a 30-day comment period on a proposal by Lake Spenard Airpark to fill 1.1 acres of Turnagain Bog along Aircraft Dr. The project includes construction of two aircraft hangers with three units each. At our March 5<sup>th</sup>, 2015, meeting, TCC reaffirmed its long-held position of advocating for protection of the remaining high-value wetlands in Turnagain Bog.

#### TCC Committee Recommends Spenard Beach Park Improvements

With approval to form an ad hoc committee at our March 5, 2015, meeting, the committee met in June to provide recommendations for expenditure of the funds anticipated to be donated to the Anchorage Park Foundation. These funds were originally collected for improvements to Didlika Park, but were no longer needed for that purpose. On June 25<sup>th</sup>, the committee forwarded its recommendation to the TCC Board to request that APF use the TCC donated funds on improvements to Spenard Beach Park, including installation of two additional picnic tables and a dog waste station.

#### • Heritage Land Bank 2016 Work Program & Five-Year Management Plan Update

The HLB Advisory Commission approved these documents at their July 9<sup>th</sup> meeting. Some of the recommendations TCC approved at our May 7, 2015, meeting and submitted for consideration to HLB were incorporated by the Commission. The final step is approval by the Anchorage Assembly.

## • Trees Planted at July 11<sup>th</sup> Balto Seppala Park Fix-It Day

The Municipal Parks and Recreation Dept. and the Anchorage Parks Foundation sponsored a June 11<sup>th</sup> park improvement day at Balto Seppala Park. With the help of volunteers — **including Mayor Ethan Berkowitz** — and Community Work Service, six trees were planted on the southeast area of the park along Milky Way Dr. These trees were donated by Dan and Cathy Gleason, in commemoration of their 35<sup>th</sup> Anniversary (August 9<sup>th</sup>). #### • Herbicide Used in Lake Hood & Spenard Lake to Fight Invasive Elodea Plant

Due to the presence of elodea, an invasive plant species with long tendrils that can pose a risk to aircraft because of its ability to snag rudders, the Alaska Department of Environmental Conservation (DEC) invoked its emergency authority in July to grant a special herbicide permit. This action allowed the Dept. of Natural Resources (DNR) to do initial herbicide applications in these water bodies on July 24th.

#### • Gateway Project Installed at Lyn Ary Park

A Lyn Ary Park gateway project along the Coastal Trail northwest of the ball fields was installed in late July/early August that included interpretive signs covering the 1964 Earthquake, history of Turnagain resident Lyn Ary and the park named after him as well as benches and landscaping. TCC passed a resolution at our February 5, 2015, meeting in support of this project.



#### TCC Bylaws Revisions Approved by Assembly

After TCC approved Bylaws Revisions at our June 4, 2015, meeting, they were submitted to the Municipal Clerk's Office. Following a review by Ombudsman Darrel Hess to ensure that the bylaws conformed to Municipal Code, they were then approved by the Assembly August 11<sup>th</sup> (AIM 92-2015).

#### Bicycle Fix-It Station Installed along Coastal Trail

A grand opening was held August 14<sup>th</sup> for the newly-installed Bicycle Fix-It Station along the Coastal Trail near Postmark Dr. CRW Engineering Group donated the funds and installed this station, and one along the Chester Creek Trail. Four more fix-it stations are planned in other areas. The station includes tools, an air pump and a stand to hold bikes while making small repairs. TCC passed a motion at our May 7, 2015, meeting in support of this project.

#### Northern Lights Blvd/Benson Blvd. Improvement Project Update

Work continues on the Northern Lights Blvd./Benson Blvd. improvement project. The Alaska Department of Transportation states that upon completion, both roads will be repaved, there will be new signage and striping, the majority of problematic curb ramps will be upgraded to current ADA standards, and automated traffic recorders and signal system will be improved.
