As we recently marked my one-year anniversary with the FCC, I wanted to take a moment to reflect on the past 12 months with you.

When I joined the FCC, I saw the hopes and aspirations you all held for our organization. As I have had the privilege of attending many community council meetings in the last year, I have often reflected on the unique communities that make up Anchorage. Each council has a history and traditions that speak to the needs of the neighborhood. And yet a common thread connects every council: the fundamental goal of fostering neighborhood engagement. The work of civic engagement is not flashy or fancy, and it is often critiqued. However civic engagement is part of the fabric of our democracy and touches every part of our lives. Through the work of your councils, each of you stands as shining examples of how investing in your neighborhood is an investment in a better tomorrow.

The FCC itself has grown and changed, striving to embody the aspirations many of you shared with me over this past year. We now have two full time staff, something we have not had in at least 20 years. Our organization is stronger than ever with strong leadership from the officers, a hardworking bylaw committee, refined policies and procedures, and work underway to establish a clear strategic vision. The recent April meeting provided a clear example, where I saw the board cohesively tackle a challenge as a unified team. Attendance at board meetings is high and the support of the board through these changes has made them all possible.

Our collective work over the past year speaks volumes. We have significantly expanded our training opportunities, including last year's townhalls, the now-annual Leadership & Officer Summit, and the Local Lens series. FCC staff are connecting with other community organizations to promote and further our mission. The launch of our new website, even as development continues, showcases the enhanced capabilities of our organization.

2026 will be the Federation of Community Councils' 50 year anniversary. While we celebrate this progress, we know there is much more to accomplish. I am excited at what we have coming soon and what the future may hold. Thank you board members for your generosity with your time and wisdom. Thank you Assembly and community partners for your trust and guidance. Thank you Community Councils for your support and dedication to civic engagement. Thank you all for making the Federation of Community Councils the organization it is today.


