

# Let's talk about WHY we budget & HOW it's decided.

## WHY CARE ABOUT THE MUNICIPAL BUDGET?

The Muni budget affects our daily lives:

- Snow removal & road quality
- Emergency service response times
- Libraries, playgrounds, parks and trails

The budget is a reflection of the values, vision and priorities of our community. We fund what is important to us.

And it keeps our large, complex, spread-out organization functioning smoothly!



## WHAT'S IN THE MUNICIPAL BUDGET?

- Operating Budget: core services like fire, police, parks, libraries, roads & health
- Capital Budget: Bonds & Grants for Projects
  - Bonds for roads, parks, municipal facilities and public safety vehicles
  - Requests to the state and feds for capital grants
- Enterprise and Utilities Budgets: Port, Solid Waste Services, AWWU, ACDA, etc...
- Dedicated Taxes: Revenue for Specific Purposes
  - Bed tax: 4% general government, 4% tourism promotion, 4% convention centers
  - Alcohol tax: public safety, homelessness, substance misuse prevention & response
  - Marijuana tax: early education & childcare (now ACCEE Fund)
  - Other special tax levies: police tech like body cams, fire & EMS, snow fleet vehicles

## **CAPITAL PROJECTS**

- Capital Improvement Plan (CIP) 6-year plan for road, parks, library, facilities projects
- Capital Improvement Budget (CIB) bonds, state, federal & private requests for the current year
- Community Councils do CIP surveys in the spring
- State & Federal funding has dropped off.
   Most local projects paid by voter-approved bonds, plus pass-through money for transportation projects



# THE COLOR OF MONEY

2024 Municipal Revenue reported in April 2025.

### WHY SO MUCH PROPERTY TAX?

State investments have been shrinking.

- In **1982**, State grants to the Muni funded about **42%** of our operating revenue. Property taxes were about **36%**.
- In **2024**, State Community Assistance funding was about **0.5%**. Property taxes are about **58%** ... with a lot more roads, facilities, neighborhoods & infrastructure to maintain!
- In the last 10 years, the Muni got \$700 million less State money: \$100 million less for operations, \$600 million less for capital.

# WHAT DOES THIS MEAN FOR LOCAL SERVICES?

- MOA in good financial health balanced budgets, nearly 100% COVID costs reimbursed by FEMA & new sources of revenue through marijuana and alcohol tax
- Therefore, MOA doing more with less:
  - 1983 Budget: \$193.5M (**\$629M** in 2025 dollars), **211K** residents
  - 2025 Budget: **\$648M**, **291K** residents ... that's **\$750 less** per capita.
- Who pays our costs has shifted from State to local residents.
- We use property taxes more, to pay for the same level of service.

## MOA SPENDING ON HOMELESSNESS

- **2020**: First year of MOA operating funds towards shelter (\$735K) + \$300K for Home for Good supportive housing pilot program
- **2025**: \$4.5M for homeless services (shelter & support) + alcohol tax grants to providers.
- 6.7% of spending on housing and homelessness from 2016-2025 has been local MOA funds. 19% has been from alcohol tax.
- **\$50M** of COVID funds went to long-term solutions: nonprofits purchased & renovated **15 facilities** (aging hotels), adding **600+ units** of affordable and supportive housing. Another **\$27M** went to rent & mortgage assistance.

# WHAT ABOUT SCHOOL FUNDING?

- School funding is part of your property tax bill, but not represented in the general government budget!
- About 45% of our property taxes go to Anchorage School District, to fund public schools.
- The School Board follows the State's fiscal year (July 1-June 30) and prepares its budget for adoption by March.
- The Anchorage School Board approves an annual budget and sends it to the Assembly for adoption ... but the rules are different:
  - Only the top-line number is approved by the Assembly.
  - The School Board makes all line-item decisions, including cuts if not fully funded.

## **HOW & WHEN IS THE BUDGET DECIDED?**

- October 2: Mayor releases proposed FY26 budget
- October 7: Budget documents formally introduced on agenda
- October 10 & 24: Assembly worksessions, FY26 budget
- October 21: 1st Public Hearing at Assembly Meeting
- November 4: 2nd Public Hearing at Assembly Meeting
- November 7: Assembly worksession, proposed amendments
- November 18: Assembly amendments & vote at Meeting
- April 2026: 1st Quarter ("1Q") Revisions process & 2026 tax levies set










#### 2026 Proposed Financing Sources \$666.2 million




Capital Improvement Budget (Sources)

# **About the Budget Advisory Commission (BAC)**

 Purpose: provide the assembly, the mayor, the school board and the superintendent of schools well-informed advice as to the budgets and budgeting process

#### Also:

- Participate with the assembly and the mayor in the review of the budgets
- Publish resolutions regarding the budget or other fiscal issues
- Work with the assembly and mayor to increase public understanding and involvement in budget and fiscal issues
- Meetings are open to the public for attendance (virtually or in person)

# Why to Care or Be Involved

- The context around municipal finances is shifting
- Local leaders are asking for input
- Broader participation leads to better outcomes

# How to read the budget...

- Start with the "Budget Overview",
  - Next "Revenues" and Appendix A
  - Then "Fiscal Program"
- "120 Day Memo" is a great resource to understand the Mayor's priorities
  - Four-page summary in plain language
  - Appendix A is one page: shows projected revenue
  - Appendix B is one page: shows how property tax budget is calculated

  - Regular updates from the Mayor's office, Assembly, OMB, and Anchorage School District
