In 1994, the organization Victims for Justice requested the use of Hostetler Park to create the Alaska Victims' Memorial, which recognizes victims of homicide (currently over 200 names on the memorial site). – Victims for Justice are working with the Downtown Rotary to bring new renovations to Hostetler Park. Presented to the council were design plans of what they hope the park will look like after the new renovations, a much more open and welcoming look. There were no objections by the council.
