   Gave update on: Renewal of Pakalolo license, intro of budget for 20-21, Safety lighting

   department of treasury gave ways to accomplish this. Will purchase all buildings.

  - Census was low but census will be extended to Oct. 30. 90%ile for census now
  - Absentee ballots went out yesterday, 100,000 ballots requested. In person voting Cook Inlet, City Hall, Sears Mall, University and airport, Absentee ballots won't be counted until Nov. 10.

  - Ship Creek to Tudor has homeless people hanging out/camping.
