Rasmussen Foundation – Richard Mandsager / Weidner Properties – Greg Cerbana

- Rasmussen and Weidner have a partnership with private and public entities working together
- Current Project on 3rd Ave. of Weidner and Rasmussen, smaller shelter with resource hub to help people move on.
- Weidner funds acquisitions and renovations. Currently working with Brother Francis not to house more than 120 people, and Bean's Café.
- Other smaller and distributed places with hubs are being worked on. Purchases should close soon.
- Beans Café to be in a new location with a large kitchen and will distribute food to other areas.
- The entities will return to the committee with updates
- Chris Constant infrastructure roads, for safety municipality will be responsible for also establishing a midtown site.
- Dept of Health and Social Services Dave Scordina Emergency doctor Regional Hospital
- 3 vaccines approved all are new,
