## ANCHORAGE DOWNTOWN COMMUNITY COUNCIL

#### **RESOLUTION NO. 2023-01-02**

A RESOLUTION RECOMMENDING TO THE ANCHORAGE ASSEMBLY APPROVAL OF THE UPDATE TO ANCHORAGE MUNICIPAL CODE (AMC) TITLE 21, CHAPTER 11: DOWNTOWN LAND USE CODE.

(Planning and Zoning Commission Case No. 2022-0129)

WHEREAS, the Downtown Community Council (DCC) as an advisory body to the Anchorage Assembly was established under Anchorage Municipal Code (AMC) Section

2.40.040, Establishment of Community Council Districts; and

WHEREAS, the DCC's mission is to serve and advocate for the downtown community and its vision is to represent downtown for the betterment of the community; and

WHEREAS, the Planning Department initiated the update to AMC Title 21, Chapter 11: Downtown in January 2022, by including the DCC in monthly presentations and invited workshops to learn of our concerns and desires for downtown; and

WHEREAS, amendments to the downtown code are necessary and desirable because of changing conditions, new planning concepts, and the social and economic conditions facing our downtown; and

WHEREAS, the code update process also incorporated significant public input and engagement including interviews with developers, interviews with property owners and managers, presentations at several open houses, agency meetings, workshops with input from a working group of selected development industry professionals including architects, landscape architects, engineers, and municipal planning staff; and

WHEREAS, the code amendment is intended to provide the development and design community the land use regulatory tools that will allow them to provide new buildings in downtown to support our northern lifestyle, diverse climate, and regional identity, while helping to support economic development, tourism, cultural and historic activities, and safer streets and buildings in downtown: and

WHEREAS, the Planning and Zoning Commission unanimously recommended approval of the code update at their December 12, 2022 regular meeting.

NOW, THEREFORE, BE IT RESOLVED by the DCC that the downtown code update meets the intents and desires of the community council and the businesses and property owners it represents and is supported by the council by a unanimous vote of the members.

Block 102 – proceeding forward. Received approval from Campbell Creek Community Council for land exchange

Mt. McKinley building – commercial to housing. RP for developer by end of 1<sup>st</sup> quarter Fur Rendezvous Feb. 24 – March 5. Chinook parking lot downtown gets impacted. Information of where to park will be made known.

Sockeye lot closed 3<sup>rd</sup> and C due to Aviator construction

Project Anchorage – city wide group collectively put together ideas to present to the mayor. Those ideas are being presented to the mayor tomorrow

Three job openings at ACDA – accounting clerk, customer relations manager, customer relations representative

ACDA – Scavenger Hunt in February collaborating with Fur Rondy. Need more businesses to participate by displaying a wooden dog designed sign as part of a clue for the scavenger sign. ACDA is going before the assembly with a proposal to sell 716 building, which houses the police department, to the municipality. The police department would still be housed there. This would save the municipality money in the long run from leasing the building.

Anchorage Affordable Housing and Land Trust was incorporated October 6, 2022 and known incorporator and director on record is John Weddleton as reported by Richard Irwin.

The original Guest House MOU draft had been requested from 1<sup>st</sup> Presbyterian Church, who were known as being the future owners of the Guest House, in September.

Downtown Community Council through its President, Silvia Villamides, tabled the MOU until the March 1, 2023 DTCC meeting. An incorporator or director of Anchorage Affordable Housing and Land Trust needs to be present to discuss and sign the MOU.
