FINAL MINUTES

Welcome and Introductions were made by Therese Voehl. We have a nice number of students attending today's meeting.

Presidents Report was made by Therese Voehl. She announced several community events and encouraged those interested to attend.

Adopt the May, June, and September Minutes:

A motion was made to approve the May minutes by Sarah Wright as amended. It was seconded by Scott Bailey.

We will approve June, September, and October at the November meeting.

Treasurers Report: Patsy Gunn was absent.

Assembly Update: No assembly members were present.

Old Business:

Select representatives for Chugiak/Eagle River Parks and Rec Board of Supervisors: It was clarified that Sarah Wright can serve for 120 days. We are actively looking for a replacement and Sarah explained the duties and responsibilities involved.

Council Comments for the draft of the Chugach State Management Plan: Therese read off some of the highlights and asked if folks had a chance to read over it and there was a general opinion. The draft is due to be approved by October 30. There was a mention that the plan lacked a mention of security of the trail heads. Sarah said that we should consider adding the Wallace Homestead to the Chugach State Management Plan.

Bill Tucker proposed a resolution that WHEREAS: 1. The Wallace Brothers mountain properties provide excellent access opportunities to the Chugach State Park systems; 2. The properties are suitable for a wide range of recreational activities; 3. The properties are appropriately maintained and operated by the Chugach State Park administration; 4. Traffic impact on the Skyline Road are expected to be off hours and minimally impacting to peak traffic flows; 5. The properties should be retained for the future use of the community and it's posterity, and not restricted from use by private development.

Therefore, the Eagle River Valley Community Council hereby resolves to recommend acquisition of the properties by the Municipality of Anchorage, contingent upon development of appropriate Memorandum of Understanding between the Municipality and the Chugach State Park providing for maintenance and operation of the properties by Chugach State Park for the benefit of the community. Therese made a friendly amendment to start at 'Therefore'... Bill Holland suggested putting on our CIP list. After much discssion, Mr. Tucker agreed to table the motion until after talking about the CBERRRSA report.

Wallace Homestead Development: Bill Tucker, Colony Home Investments: see above conversation.
