Presentation by Ian Laing – Alaska’s Future Executive Director

- Need a continuing budget plan

- Believes some use of Permanent Fund is necessary

- 90% of oil revenues provide for state budget

 - Difference now is lower production and lower prices

- Previous deficits were around \$800 Million and are now in the billions of dollars

John See – Anchorage Fire Department Forester

- 2001 to 2016 have spent \$16 Million on Spruce Bark Beetle mitigation

- Fire Wise Program is effective

 - Thin Spruce – Clear around house

 - Leave Hardwoods

 - Clear further downslope

- Last season of fire funding – Up to \$500 max

Public Land Treatments coming this summer

- State Park Land – Around Denaina Drive in May

- Ravenwood Elementary - will prune and trim.

 - School Sites are safety zones – will help this one comply

Open House May 30 from 10 am to 4 pm at the Training Center

Firewise inspections program

- Have 150 Home inspections complete

- Have 100 applicants remaining - may end in 2016

Will operate the woodlot program again this summer.
