HIGHLIGHTS OF THE COUNCIL'S JULY MEETING

Meeting called to order by President Darrel Hess at 7:07 pm.

Secretary's Report, Sharon Chamard:

There was no quorum, hence no motion or vote to approve the minutes of the June General Membership meeting.

Treasurer's Report, Harry Deuber:

No report

APD Report, Sgt. Cindi Stanton:

A meeting was held recently with members of the Public Safety Committee to discuss various issues. As a follow-up, call histories were run on two properties mentioned during the meeting, and nothing significant turned up.

A gang unit has been established at APD. Some officers will be redeployed from units working on drug house and prostitution cases, so there will be fewer officers in those units for the next two to three months until the new recruit class becomes active

Questions and comments from the general membership concerned the following:

Q: How can the Violent Crime Compensation Board be contacted?

A: Their number is 1-800-247-9763

Q: What is the makeup of the gang task force? When is their next meeting? Is the task force strictly internal to APD?

A: Yes, it is internal. If people have questions, they can call Sgt. Gil Davis.

Q: Is there an effort to look at the lower grades in schools?

A: Lt. Cobb is in charge of the officers in schools program, so yes, there is a focus on schools.

Comment: The police can't deal with gangs by themselves; community input is needed.

Guests and Presentations:

Teri Albrecht, MOA Community Capital Coordinator

This was a short presentation on the process concerning the capital projects wish lists. So far 19 of 38 community councils have submitted their lists. The lists go to Ms. Albrecht, Bruce Holmes, and Jim Lamson in the Office of Management and Budget for review. More information will soon be put on the MOA website, and there is also more information on the Federation of Community Councils website. The municipality is putting on workshops on Context Sensitive Design on July 28th to advise citizens on the project design process, so they can get involved in things from the beginning. Ms. Albrecht commented that the Fairview Community Council's Neighborhood Plan Workshop this past March was the best such workshop she has ever attended, and that this community is "already doing it" and can look forward to help from the MOA.

Assembly Report, Allan Tesche:

Mr. Tesche has recently started an Assembly Report blog. It can be accessed at http://teschereport.blogspot.com/. It is posted every Wednesday morning, and e-mails are sent to people telling them the blog is available.

At the last meeting the Assembly

Did not resolve the discussion about operating conditions for the "Call of the Wild."

Passed an ordinance restricting the use of eminent domain in Anchorage.

Rezoned property in south Anchorage for a Sports Dome.

Continued discussion on Janice Shamberg's proposed ordinance on bicycle helmet use for children.

Approved the first step of a transfer to the Anchorage Community Development Authority of 25 acres of land at Mt. View Dr. and Bragaw St. for the possible construction of a regional shopping center. This is an exciting project that promises change for Mt. View in keeping with its "Arts District" plan. There is also money in the Governor's budget to bring back the Mt. View library.

Postponed action on the neighborhood planning ordinance until August 9th. Some Assembly members do not like these neighborhood plans because they think this should be left to the municipality and there should not be involvement of outside groups.

Approved the conveyance of property in Eagle River for Chugiak Senior Housing.

Postponed action on legislation that would allow ML&P to work with other railbelt utilities to build future generation and transmission facilities.

Approved Dan Coffey's proposal to relax current charter provisions that limit parking and traffic enforcement to sworn APD personnel. If the charter amendment passes in the April 2006 election, the ordinance would allow the Chief of Police to "designate" municipal employees empowered to issue parking tickets.

Questions and comments from the general membership concerned the following: non-enforcement of handicapped parking, the size of the school board budget, lack of area-based representation on the school board, a proposal for a loop van program, the increase in the Fairview Elementary budget coupled with a decrease in student performance, and the importance of the neighborhood plan process.

Juneau Report, Les Gara:

Since Johnny Ellis's report to the community council last month, we worked hard to make sure the Governor would not veto certain budget items. Several discretionary projects affecting Fairview will receive funding:

13th and Gambell for planning and/or construction of pedestrian improvements

Neighborhood Health Center

Kitchen upgrades for Bean's Café and the Food Bank

Books for Fairview Elementary

Dan Loring remarked that Title 1 funding in the state is at an all-time high, and while funding at Fairview Elementary has gone up, student performance has gone down. Yet no one is talking about it. Les Gara replied that increasing budgets might not be enough in areas like Fairview and Mt. View where there are many homeless children, and that increasing budgets cannot cover increasing costs as well as reduce class size. Regina Manteufel suggested that legislation be passed to force parents to attend meetings quarterly to hear about programs at the school and their own child's performance, and that if they don't attend these meetings, they would not be permitted to register their children at the school. Les said he had tried something like this before that tied attendance at PTA conferences to receipt of the PFD, but it turned out to be administratively unfeasible.

Committee and Community Reports:

Ad-Hoc Block Party Committee, Darrel Hess:

The Block Party is this Saturday from 11 am to 4 pm at Fairview Lions Park. Members of the Chappy James American Legion post will be tending the grills, and the principal of Fairview Elementary, Dr. Marc Robinson, will sing the national anthem. The program will start at about noon, and Mayor Mark Begich will declare July 16th as Fairview Community Pride and Diversity Day. The following awards will be made – the Beautification Award to Anchorage Memorial Park Cemetery, and the Citizenship Award to Lee Ross.

Regarding fund-raising for the Block Party, Darrel and Sharon approached 22 or 23 Fairview businesses, and overall were disappointed with the response, especially from the larger car dealerships. However, many thanks go to those businesses that did make donations: the Crossroads Lounge, Affordable Used Cars, First National Bank, Bill Webb and the Downtown Market, and VF Grace. Special notice is made of Barry Turner of Barry's Baranof Lounge for his continued generosity to the Fairview Community. Last year he gave \$2,500 to the Block Party, followed this year by a \$1,000 donation. He also donated \$1,000 to World Changers a few years ago so that a senior in Fairview could get her roof redone, and \$1,000 to the Hanson substation.

Education, Dale Myhill:

Dan Loring is applying for a position with the Minority Education Concerns Committee. The Executive Board at its last meeting gave approval for Darrel Hess to write a letter supporting Dan's application.

Neighborhood Plan, Noel Rea:

At its last meeting, this committee reviewed the Title 21 material. It will be discussed in subsequent committee meetings, with a resolution presented at the August general membership meeting and voted on at the September general membership meeting.

Public Safety, Sharon Chamard:

Members of the committee met recently with Sgt. Cindi Stanton. Details of the meeting are written up in this month's newsletter, so won't be covered in

There is a continuing problem with a small homeless camp in the alley behind a house in the 800-block of E. 13th Ave. Sharon called zoning and code enforcement and talked to Cindi Stanton about the matter and was disappointed to learn that there is very little that can be done. A cardboard tent does not count as a building, so there is no violation of code in respect to how many dwelling units can be on a lot. As long as the property owner is allowing the homeless people to stay there, the police can't do anything to remove them. Several people made suggestions, such as calling Channel 11 because they do stories on folks who are dissatisfied with the muni's response to problems, tracking down the deed of trust and meeting with the mortgager, and contacting the

Zoning, Dan Loring:

This committee meets the first Wednesday of each month at 6 pm at the Rec. Ctr. At the most recent meeting, the committee developed a "top ten" list of properties and infractions. To deal with these, a procedure similar to that used by the Public Safety Committee will be followed. With respect to Fairbanks Park and the problems there, this could be addressed by the Zoning Committee if it within the scope of the committee. We need a scope of work from the Executive Board.

Community Comments and Concerns:

Regina Manteufel - the Eazy Inn on Gambell St. is getting fixed up.

Justina Meyer - the four-plex at 1244 Hyder St. is up for sale. The muni sped up the process to make the owner do something with the property.

Darrel Hess commented that a big reason for action on that property is because it had become a public safety issue. Buildings that are just boarded up and left in an unsightly condition do not have a high priority unless there are safety concerns.

Dan Loring remarked that he had mentioned at the last Executive Board meeting that it would be a good community project to get a group of people together to buy the 1244 Hyder property.

Noel Rea – we had success getting the rehab project at the Habitat house in the 1200-block of E. 12th Ave. shut down. They were receiving as much as \$15,000 in CDBG funds through World Changers. But the

owners of the house have been indicted for having stolen property. Anchorage Neighborhood Housing Services has said there will be a better vetting process of applicants next year.

Allan Tesche said that hearing that the neighbors were going to bring this to the attention of Channel 11 was helpful to me in getting the cooperation of the administration.

Dan Loring – The clean up of Fairbanks Park has been rescheduled for July 19th, starting at about noon. I've been making contact with neighbors near the park, as well as with Comtec, and they are excited about the possibility of fencing on the south side of the park, and the installation of cameras that could be viewed on the Internet.

Darrel Hess said that he and Sharon recently went with Doe Anderson to the park. She is investigating the fence possibility regarding utility line easement.

Dan Loring - I'm applying to get on the Minority Education Concerns Committee and would appreciate letters of support.

Meeting adjourned at 8:32 pm.
