# Girdwood Trails Committee Minutes of Regular Meeting Girdwood Community Center, 7:00 p.m. Tuesday, May 3, 2011

### Call to Order

# **Approval of Agenda**

The agenda was approved with the addition of Mark Ryan's zip line proposal to the beginning of the meeting.

### **Introduction of Guests**

### **Old Business**

### <u>Trail Issues</u>

• <u>Zip Line Proposal</u>—Mark Ryan presented his proposal of a zip line on state land near Eagle Glacier and the head of Winner Creek. The zip line equipment would be entirely on snow and taken down each fall. Access would be by helicopter only, and the flight pattern would most likely follow the Upper Winner Creek Trail. He will require a land use permit and seasonal recreation permit. After considerable discussion, the Committee passed the following motion, 9-1.

**Motion (Brian and seconded):** The Trails Committee does not object to the land use as proposed by Alpine Zip Line, but we are concerned about noise impact over trails.

• <u>Hand Tram Issues</u> – The Committee agreed that Jonnie order a backup rope and an extra rope for the future because of the good price that saves money in the long run.

Brian and Jonnie have both been working with Superior Tramway to evaluate the retrofitting and/or reconstruction of the hand tram. Brian has contacted Mike Siedl, who worked on the construction of the hand tram in Kachemak Bay State Park, and the owner of Unique Machines, who may be willing to design parts for the cage. Jonnie and Brian will work more on this during May; the tram will stay locked for the month.

• Beaver Pond Trail and Survey—MOA Parks and Recreation city planners have

agreed to help us with the trail reconstruction and will come out to walk the trail in May. Jonnie will send out an email to those interested in walking the trail with them. The planners are also interested in avoiding high costs to survey Abe's Trail and California Creek Trail.

• <u>Moose Meadow Trailhead and Parking Lot</u> --Jonnie is working with MOA to design and build a new trailhead and parking lot. She has made considerable progress and city planners agree to begin the process. To that end, the following motion was passed, 8-1 abstention-0:

**Motion (Kate and seconded):** The Trails Committee approves in concept an improved trailhead and parking lot at Moose Meadow.

A sign needs to be made that says "Ski Trails" at the juncture of the Moose Meadow groomed loop and the spur to Horror Hill.

#### Summer Crew Plans

Signs will have to be made for directions at the Y and for the Beaver Pond Trailhead on Crow Creek Road. Matt Wedeking plans to replace the blue sign for Beaver Pond Trail on the Gird-to-Bird Pathway, and we hope to save that sign.

### New Trails Maps

The group spent considerable time editing the maps and the text for directions. Kate will tell Todd about the map changes, make the final edits on the text, and send out final text for approval. Carolyn will take it from there.

### <u>Updates</u>

- Memorandum of Understanding—Kate reported that John Rodda wrote that he
  has taken our suggestions for changes to the MOA Legal Department and will get
  back to us when they have responded.
- <u>Conex Crew Plans, May 7 and 8</u>—Brian will call John about the loader; Jonnie and Kate will bring food and drinks to the crew. Carol will donate coffee.
- <u>2011 Biennial Trails Rondy</u>—Brian reported that he went to the Rondy on behalf
  of Girdwood Nordic Ski Club and that he made many contacts and went to a lot of
  helpful sessions for all Girdwood trails. He would like to bring the statewide
  group to Alyeska Resort in the future.
