7:10 Meeting called to order by Andre Camara, president. Introductions of those present were given by name and neighborhood.

Minutes were approved with amendments by consensus.

7:15 **Reports:**

Jim Frederick of NeighborWorks announced that they are delaying a funding application for a proposed development on West $23^{\rm rd}$ (between A St and C St) until next December. NeighborWorks will bring plans back to the Council next Spring. Vice president's /FCC Delegate's report: Gordon Glaser reported on the progress of Title 21 and the State of Our City conference.

Treasurer's report: Barbara Pepek reported that on Oct 15th, 2011 the Council had a balance of \$719.54.

7:20 **Legislative Reports:**

Rep Mike Doogan: Charles Boyle, aide to Rep Doogan, reminded us that the legislature resumes in January.

Rep Les Gara: Toby Smith, aide to Rep Gara, was present.

7:25 **Assembly Reports:**

Harriet Drummond was not present as she is Outside attending the League of Cities meeting.

Ernie Hall reported that testimony on the municipal budget was sparse and expected that the budget would be passed on Dec 6th. The Assembly approved the legislative packet for district projects using the community councils' CIP lists. VIP committees are being formed to work on public parks within the community councils. NorthStar CC has few, if any, parks that need work.

An ordinance banning the manufacture of a synthetic cocaine product was passed and goes into effect immediately. This augments other measures passed recently as new compounds continue to be introduced to the market.

7:30 **Presentation:** 2035 Anchorage Metropolitan Transportation Plan – Bob French, Gov Hill representative: Concerns were raised that KABATA, the Knik Arm Bridge project, are included in the municipal plan.

7:55 **New Business:**

A motion was introduced by Mark Butler, 1) Gordon Glaser 2) Ira Perman and passed unanimously to write a resolution to:

- A) Remove KABATA from the AMTP 1) Jeff Landry 2) Susan Miller
- B) Remove A/C complete restriping

- D) Support Spenard Rd reconstruction-Hillcrest to Benson Blvd
- E) Support removal of state-owned DOT building at Benson and Spenard.

Code violations within the Council: Cora Weaver, MOA

Sunrise Bakery has been given another extension on parking semi-trailers on B-3(commercial) land on the East side of Spenard Rd. The bakery is permitted to continue the practice until May 4th, 2012. Alan Rosenthal recounted that this complaint was filed in 2004. To date no fines have been levied for the violations. Ernie Hall, Assembly member, explained that Jerry Weaver, MOA, made the decision to extend 4 extensions in 2011- June, September, October and November.

It was decided to invite Larry Brandt of Sunrise Bakery and Jerry Weaver of MOA to December's meeting to discuss the situation. A copy of the agreement between MOA and Sunrise Bakery was also requested.
