Re: Pressure Zone Modifications – 475 Loop Conversion

Dear Customer,

Anchorage Water and Wastewater Utility (AWWU) is hard at work finding ways to provide you the most affordable, reliable water service. The water pressure zones in your area can be consolidated and simplified, improving water quality and water distribution, and allowing for the decommissioning of unneeded system components. This adjustment may change the water pressure in your home or commercial building.

The attached project area map details where this change in water pressure will take place in your community. Affected properties will see a minor decrease in pressure as a result of the pressure zone change. Although we do not expect most customers will notice any change, this pressure decrease may cause some existing compliant fire sprinkler systems within the project area to function inadequately. For this reason, AWWU is seeking to identify and analyze all fire sprinkler systems within the project area to determine impacts of the proposed water pressure changes.

If your property has a fire sprinkler system or if you are unsure, it is important that you reach out to the project team using the contact information provided below to discuss the next steps. If you have already been in touch with AWWU or its agents, please reach out to us again to confirm that you have provided all available information about your fire sprinkler system and to ensure we have the best contact information for you. Please note that AWWU is not inspecting or enforcing fire sprinkler system code compliance, but only determining which properties have fire sprinkler systems and if our project will impact your property.

If your property does not have a fire sprinkler system, no further efforts are required. You will continue to receive project newsletters, updates, and invitations to public meetings as the project progresses. The project team will be attending the upcoming Scenic Foothills and Northeast Community Council meetings, February 4 and 18, respectively.

Thank you in advance for your participation and patience as AWWU works to improve your water system.
