We heard about the Huffman Road Design from Steve Noble of DOWL Engineers. Lance Wilber, Manager of Municipal Transportation, explained the Hillside Sub-Area Transportation Study, the connection from Goldenview Dr. to Mt. Air Dr. and Bear Valley soon to be heard before Planning & Zoning. The great folks from Parks and Rec, Shawna Popovici (SE District), Holly Spoth-Torres, Art Eash, Heritage Land Bank, Trails Coordinator, Lori Schanche and Tom Harrison from Chugach State Park spoke and fielded questions about parks and trails and future plans. **Legacy Pointe Senior Housing Plan Hearing Update**

This development is located west of Goldenview, south of 172<sup>nd</sup> Ave and east of the gas line that runs along the bluff above Potter Marsh. The developers presented their plan at the October Community Council meeting to a large group of concerned neighbors. They outlined a plan for senior housing for those over 62 years old in a retirement community of 12 buildings, 5 stories high, with 55 units each ranging in size from 1360 to 3,000 sq ft. In all, 6.3 dwelling units per acre. There will be a condo homeowners association to take care of the property once units are sold. This land is zoned PLI (Public Lands & Institutions).

The first phase of development is scheduled for two buildings just off of Goldenview Dr. The phasing will continue an estimated 5 to 7 years for full development.

A road is planned to span Goldenview south to Potter Valley Road, but the alignment and grade are yet to be determined. The secondary access routes are planned through the adjacent low density subdivisions on Bettijeau St., Kallendar, 172<sup>nd</sup> Ave, Belarde and Virgo. The developer does not intend to join the South Goldenview Limited Road Service Area.

The historic Moen Trail will be moved to follow the alignment of one of the creek drainages through the property, where there is to be a natural vegetative buffer.

**Hillside District Plan Update**

The Hillside District Plan (HDP) is in progress and within a year, it should provide guidelines for citizen-determined development standards in SE Anchorage. In the meantime, subdivision construction continues. Some developers are asking for variances. When variances involve issues of density or public utilities, this undermines the public’s ability to determine their preferred ideals for safe and attractive neighborhoods. The upshot of increased density or public utilities—on the steep, wet slopes in our council area—is far reaching. Wholesale clearing, recontouring of slopes, and trenching hillsides for water lines have resulted in enormous drainage problems and even a massive mud slide. Therefore the request for public utilities raises many questions.

The developers of Views at Prominence Subdivision (east of Prominence Pte) have applied to the Regulatory Commission of Alaska for a ‘Public Convenience and Necessity’. In brief, this would create a water and sewer utility for a 100-acre subdivision that is outside the city’s public utility boundary. The application states that the city can’t supply water, which is nearby in the Prominence Pte subdivision, due to lack of capacity. The application rationalizes the need for community wells (each with an accompanying 140,000 gal. above ground tank), because individual well capacity might vary due to high rock in the area. The developers originally planned on providing a self-contained high tech wastewater collection system for the whole subdivision, but now are asking to move sewage to Prominence Pte, 200 ft from their boundary. **December 11 P&Z Meeting for Hillside Sub Area Transportation Study**

There will be a meeting on Monday, December 11 at 6:00 p.m., Loussac Library reviewing the Hillside Sub Area Transportation Study.

During the last RCCC meeting, Lance Wilber, Manager of Municipal Transportation, summarized the results of the Hillside Subarea Transportation Study performed for 550-acres of the Hillside area of Anchorage. According to the Transportation Study available at [www.muni.org](http://www.muni.org), the study area consists of seven proposed subdivisions. The site is situated south of Rabbit Creek Road, east of Golden View Drive and west of Carl Street. The area is currently undeveloped and is occupied by woodlands and some wetlands, with significant topography changes.

The Transportation Study states five purposes for the plan: to establish neighborhood collector roadways; to identify the impact of neighborhood traffic on nearby roads; to recommend roadway design criteria; to recommend the location of trails and bike paths; and to make recommendations to assure safe pedestrian and bicycle facilities.

During Mr. Wilber’s presentation at the RCCC meeting, he stated, “The study suggested a housing density between 440-550 houses with access to the properties that extend from Goldenview Drive and Rabbit Creek Road between 156th and 162nd to Prominence Pointe Drive, Mountain Air Drive, and Clarks Road. The safety of existing and future homeowners is a priority.”

Rabbit Creek Community Council General Meeting Minutes [DRAFT]  
Bear Valley Elementary School, Anchorage  
November 9, 2006

Chair Susanne Comellas opened the meeting at 7:00 pm. Other board members present were Peter Crimp, Donna Van Flein, Dianne Holmes, Wayne Skidmore, Gretchen Specht, Charlie Barnwell, Dick Tremaine, Peter Johnson, Ky Holland, and John Isby. About 130 people were in public attendance at this meeting in response to a mass mailing to all households in the RCCC area.

**Minutes** – Motion by Wayne Skidmore with a 2<sup>nd</sup> by Peter Johnson to approve the October minutes. Motion carried with no objections.

**Treasurers Report** – The treasurer (Donna Van Flein) reported a bank balance of \$599.02 and 120 members.

**Legislative/Assembly/ASD/APD/Mayor’s Office Reports**

No reports by Assembly, ASD, etc. due to tight schedule of the meeting.

**Announcements**

The Title 21 Rewrite will be heard before the Assembly in December and deserves our attention because it will effect our area—given the large amount of undeveloped land.

**Old Business:** Rabbit Creek Community Church expansion: Update— the request was denied by P&Z. The Church plans to appeal this decision.

Forest Heights/Legacy Pointe Subdivision Site Plan: P/Z is scheduled to hear this case Jan. 8, ’07. Maps were posted with a summary of the proposed senior housing project.

Another large, high density subdivision, Potter Hts/View Point, adjacent to Legacy Pointe will be coming before the Platting Board soon.

Huffman Road Design: Dowl Engineers, Steve Noble presented a map of the proposed design from the Old Seward Hwy to Lake Otis Pkwy. An open house will be held Dec. 14<sup>th</sup> at Bowman School.

Hillside Transportation Plan—An update on the Bear Valley/East Goldenview subarea circulation plan was provided by Lance Wilber, Manager of MOA Transportation. The plan has not been adopted but remains a tool for master planning of roads and trails as individual land owners come forward with zoning and planning requests. Questions focused on the need to continue this planning effort in the other undeveloped sections of the Rabbit Creek Council boundaries. Wilbur presented maps that reflected a network of roads and trails. He discussed how trail connectivity had been emphasized in this study.

Anchorage Police Department Report: Cindy Stanton made a brief report.

Report by Lori Davey, Golden View Limited Service Road Area Chair: Drainage and other issues reported by Lori with a focus on attempting to shift the Goldenview LRSA to a Rural Service District in order to qualify for, and use bond funds for construction activities currently prohibited for MOA LRSAs like Golden View. They are also concerned about the impact of new development that can not contribute to the necessary upgrades and repairs to roads due to damage from the new developments.

**New Business:**

Board Elections: led by Peter Johnson. Nominations made, candidates listed. Ballots distributed to audience, and voting took place. The new members take office in January, 2007. Results of the election are posted on the FCCC ([www.communitycouncils.org](http://www.communitycouncils.org)) RCCC web site.

A comprehensive trails strategy has been developed by the RCCC but remains in limbo with city and state agencies that either (a) don’t have planning money (CSP) or (b) want to see a review and adoption of new trails plans left to government sponsored planning efforts, for example the ADNR Chugach State Park Trails Access plan, or the MOA Hillside District Planning process.
